

## **Recommendation Report of The Deputy Conservator of Forests, Dharwad Division, Dharwad**

On 10-12-2021 along with the Survey RFO, Deputy Range Forest Officer (Kalkeri Section) Dharwad, and staff and representatives of User Agency viz Executive Engineer PWD Division, Dharwad and Assistant Executive Engineer PWD Sub division, Dharwad. I have inspected the proposed site for Diversion of 0.9850 Ha of Forest land for improvement of road from Kalakeri to Hunashikumari Village, Dharwad Taluk, Dharwad in favour of Executive Engineer, PWD, Dharwad. The proposed diversion area fall under jurisdiction of Dharwad Range of Dharwad Forest Division.

During inspection of the proposed site for Diversion following points were observed.

The proposed site for diversion is situated at Kalkeri and Hunashikumari reserve forest.

No trees felled in the proposed area.


Justification given by User Agency in their letter no Forest proposals/PWD/DHARWAD/15/07/2021 Dated 15/07/2021 addressed to The PCCF (FC) AND NO (FCA) states as ;

- There is no alternative existing road between Kalakeri village and Hunashikumari village. However there is a existing road in the revenue village map (Published in the year 1940) between Kalakeri village and Hunashikumari village.
- Presently in some stretches of this road in revenue map, the road is shifted in forest area (some survey no) by road users, due to various reasons (hill, valley, slush, pond etc) since many years to the extent of 0.9850Ha.
- This shifted road almost runs parallel to the road as per revenue map.
- More than 2000 valuable trees are existing on the revenue village road at different stretches 1.6Ha area (road which is not in use presently)
- If the road is to be constructed n the stretch as per revenue map, many well grown more than 2000 trees have to be cut/removed, which will be of great loss to the environment.
- Presently enjoyed road is proposed for improvement, the diversion of forest land is to the extent of 0.9850Ha.

In compliance of the instructions given in PCCF (FC) letter no: KFD/HOFF/A52K(GFL)/25/2020-FC Dated 26-08-2021, User Agency has acted in accordance with all the observations raised. In perusal of instructions given in letter no: KFD/HOFF/A52K(GFL)/25/2020-FC Dated 24-06-2021, temporary pillars at regular intervals of 20 meter and at all corner points have been affixed.

Diversion of forest land as proposed by the User Agency is unavoidable and bare minimum of requirements. Hence proposal may be recommended for the diversion of above said forest area for road in favour of Executive Engineer, PWD, Dharwad., as per the provisions prescribed in section 2 of Forest (Conservation) Act-1980.
