Sub: Site Inspection Report regarding rehabilitation of Dadhia Forest villagers of Dibru-Saikhowa National Park.

Sir,

With respect to the above I would like to submit herewith the site inspection report of the identified 135 ha of plot within Pabha RF for relocation of forest villagers of Dadhia forest village of Dibru-Saikhowa National Park along with the following comments –

- 1. **Relocation Plan:** AMTRON survey team would be engaged to demarcate the household plots as per the list received from him. Boundary pillars need to be erected for each household area to avoid future conflicts for which necessary fund for survey, demarcation & erection of boundary pillar required may be provided. Detailed estimate would be furnished after receiving the list of households. Survey & demarcation timeline would be determined depending upon release of fund and receipt of list of households along with the quantum of land allotted to each household.
- 2. Common facilities to relocated families & concerned deptts.: A levelled plot of land have been identified by the forest deptt. Inside Pabha RF where primarily no site level intervention is required. For providing other facilities Deputy Commissioner, Lakhimpur have already directed the line departments to come up with plan urgently. Different plantation activities under CAMPA, SOPD and Schemes of SMPB, Assam may be taken up for taking care of livelihood.
- 3. **List of Stakeholders:** Besides Forest deptt. & the relocated families, District administration, line departments identified by the Dy. Comm, Lakhimpur & local bodies are the probable stakeholders.
- 4. **All facilities to be made available at Relocation site:** Apart from providing a leveled piece of land inside Pabha RF, other line deptts. identified by the Deputy Commissioner, Lakhimpur would be involved for an integrated approach towards providing infrastructural & livelihood facilities viz., connecting roads, water supply, primary educational institution, basic health facilities, farming support, animal husbandry etc.
