This road is the only lifeline of Peren linking Kohima the state capital and Dimapur the commercial hub. This existing road was constructed in private land and was in used for many years before the Forest Department purchased the land on which this NH-129A passed through. As such granting of forest clearance for construction of the existing road earlier does not arise
