**Sub: Proposal for according permission for use of 7.94 ha. of forest land within total Mining lease area of 265.29 ha. in Dalki Iron and Manganese ore Mining lease located in Barbil Tahasil and Barbil Forest Range of Keonjhar Forest Division in Keonjhar district for undertaking exploratory drilling of 59 no. of boreholes of 4" dia (59 boreholes @ 0.02 ha each totalling 1.18 ha and 6.76 ha for construction of road) by M/s Odisha Mining Corporation Ltd. for prospecting of minerals**

Sir,

I am directed to refer to Government of Odisha's letter no. 13806/9F (MG)-87/2017 dated 27.07.2020 and 6613/9F (MG)-87/2017 dated 24.03.2021 on above mentioned subject submitting compliance of conditions stipulated in Stage-I approval dated 16.08.2018 along with details of funds deposited by user agency against compensatory levies into the account of CAMPA. It is to inform that FC Division requested the NA (CAMPA) to provide a report on remittance of compensatory levies into the account of CAMPA.

NA (CAMPA) vide their Office Memorandum no. 1-26/2017-CAMPA dated 20.05.2021 (**copy enclosed**) informed that the Corporation Bank, Lodhi Road Complex, New Delhi-110003 has reported that the remittances of Rs. 8,39,70,500.00 (part of consolidated remittance of Rs. 92,23,88,274.00 vide DD No. 083747), Rs. 9,69,56,710.00 (DD No. 650882) and (UTR No. ANDBH18305114953) have not been received in the Corporation Bank, Lodhi Road Complex, New Delhi-110003.

NA (CAMPA) Office also mentioned that the project wise and component wise breakup of the consolidated remittance of Rs. 92,23,88,274.00 has also not been furnished with the communication.

In view of above, the State Government is requested to furnish information as desired by NA (CAMPA) so as enable the Ministry to consider the proposal for Stage-II approval.
