Minutes of Meeting

The 5th meeting of the Executive Committee of the National Authority

Venue: Through Videoconferencing

Time: 03.30 pm **Date:** 23rd April, 2020

Participants: The list is enclosed

The Chief Executive Officer, National Authority welcomed the chairman (DGF&SS, MoEF&CC), all members of the Executive Committee and the officers present in the meeting. With the permission of the chair, he briefly explained the agenda items of the meeting. Thereafter, the Executive Committee took up the agenda items for discussion.

Agenda Item No. 1: Confirmation of minutes of the 4th meeting of the Executive Committee of the National Authority.

Decision: The Executive Committee confirmed the minutes of the 4th meeting held on 15.10.2019.

Agenda Item No. 2: Action taken on the decisions of the 4th meeting of the Executive Committee.

Decision: The Executive Committee took note of the Action Taken Report on decisions taken in its 4th meeting.

Agenda Item No. 3: Provisional approval of the mandatory and time bound activities of Annual Plan of Operation (APO) 2020-21 of State Authorities due to unprecedented situation arising out of Covid-19 pandemic.

Decision:

(a) The Executive Committee considered the proposal as mentioned in the agenda item in the wake of the unprecedented situation arising out of COVID-19 pandemic. Most of the APOs were received recently and it was not possible to consult all the states in respect of all activities proposed in APOs. It was, therefore, agreed to grant immediate approval for carrying out essential plantation and other activities to all the states who submit their Annual Plans of Operations (APOs) with the approval of respective Steering Committees so that time bound activities could be undertaken/completed. The states that have submitted such APOs are Andhra Pradesh, Assam, Goa, Haryana, Himachal Pradesh, Maharashtra, Meghalaya,

Tripura, Uttarakhand, Chhattisgarh, Madhya Pradesh, Mizoram, Bihar, Odisha, Jammu & Kashmir, Delhi and Andaman & Nicobar. State-wise details of approved activities are enclosed. The following activities have been approved in the first instance:

1. Site-specific activities-

All activities as per section 6(a) of the CAF Act, 2016, which are as under: "Compensatory Afforestation (CA), additional CA, penal CA, Catchment area treatment plan and any other site specific scheme submitted by the state along with approved proposals for diversion of forest land under the Forest (Conservation) Act, 1980.

2. Activities as per Rule 5 of CAF Rules, 2018-

- a. Completion and maintenance activities related to assisted natural regeneration/artificial regeneration/silvicultural operations/soil and moisture conservation works etc, where preparatory works have been undertaken.
- b. Nursery works for the above activities
- c. Casual employment of local people or labors etc. to assist regular staff of SFDs for protection of plantations, forests and wildlife including forest fire prevention and control
- d. Operation and maintenance of existing animal rescue centre and veterinary treatment facilities for wildlife
- Maintenance of modern nurseries and other planting stock facilities for production of quality planting materials
- f. Independent concurrent monitoring and evaluation and third-party monitoring of various works undertaken from State Fund
- g. Production and distribution of quality planting material through certified nurseries at subsidized price for promoting of tress outside forest on Government lands

3. Activities as per Rule 6 of CAF Rules, 2018-

- For disbursement of salary and allowances of members and staffs, both regular and contractual, of the State Authority
- (b) The Committee was also of the view that most of these activities are highly labour intensive and, thus, this measure will help in creating employment opportunities in urban and rural

areas of the country to support the livelihood needs of the poor during COVID-19 lock down period.

- (c) The Committee also observed that in some of the states, APOs have been approved by the respective Executive Committees and the approval of the State Steering Committee is pending on account of the fact that senior officers in the State might be busy with COVID-19 related work. The Committee decided that the above approval will be extended to such states whenever their APOs are received after approval of respective Steering Committees.
- (d) The Committee also observed that the States, who have not submitted their APOs for the year 2020-21 to National Authority so far, shall submit the same urgently with the approval of State Steering Committee.
- (e) The Committee observed that the activities shall be carried out in accordance with Rule 4 of CAF Rules, 2018, i.e. as per provisions of the State financial rules or any such other rules applicable from time to time in the State.
- (f) The Committee was of the view that strict monitoring of the work shall be done by the State Forest Departments. The Principal CCF & HoFF will issue necessary instructions in this regard and oversee that monitoring is being done in a timely manner.

Agenda Item No. 4: Comprehensive review regarding continuation of scheme of NICSI "egreen watch/Web based Monitoring System" as per the approval accorded on agenda no. 3 of the 1st Governing Body Meeting held on 15th November 2019.

Decision: The Executive Committee gave an 'in principle' approval to the proposal as mentioned in the agenda item. The Committee also observed that requirement of laptops for FC division should be reworked keeping in mind that the officers as the level of Under Secretary and above are eligible to get official laptops. The Committee also directed the NIC to submit the detailed proposal for the financial year 2020-21 in file with all relevant details such as funds received from Ad-hoc CAMPA in the past, availability/requirement of funds for the year 2020-21, the Utilization Certificates and Audit Report of the funds utilized etc.

Agenda Item No. 5: Extension of period to use the unspent funds available with the States/UTs beyond 31st March 2020.

Decision: The Executive Committee considered the proposal in the agenda item and directed that the details regarding the utilization of funds received from Ad-hoc CAMPA and availability of the unspent balance (as on 31st March, 2020) be sought from the respective States and thereafter, the matter may be placed in the next meeting of the Committee.

Agenda Item No. 6: Engagement of seven Consultants at various levels, six Office Assistants/Data Entry Operators and ten Office Attendants in the National Authority initially for a period of one year or till creation and deployment/filling up of the posts as per approval on agenda no. 9 (A) of the 1st Governing Body meeting of the National Authority held on 15th November 2019, whichever is earlier.

Decision: The Executive Committee agreed 'in principle' to the proposal of the National Authority as mentioned in the agenda item and observed that the proposal may be referred to IFD in file.

Agenda Item No. 7: Briefing on action taken on decisions taken by the Governing Body of the National Authority.

Decision: The Executive Committee went through the details furnished in the agenda item and desired that scheme wise releases made to various institutions may also be furnished in future.

Agenda Item No. 8(a): Proposal submitted by the National Mission for a Green India (GIM) for seeking Funds in accordance with Section 5 (b) (iii) of CAF Act

Agenda Item No. 8(c): Action on the 331st Report of the Department-related Parliamentary Standing Committee on Science and Technology, Environment, Forests and Climate Change on Demands for Grants (2020-21) of the Ministry of Environment Forest and Climate Change.

Decision: The Executive Committee considered the proposal of GIM as mentioned in the agenda item 8(a). The Committee also perused the Agenda Item No. 8(c) related to the 331st Report of

the Department-related Parliamentary Standing Committee. The Committee was of the view that clarification on section 5(b)(3) of CAF Act, 2016 in the light of explanation 2 below Rule 5 of CAF Rules, 2018 may be sought whether any existing scheme of the Ministry can be considered for funding fully or partially from the National Fund. However, it was observed that the questions should be framed properly while seeking such legal opinion.

Agenda Item No. 8(b): Proposals submitted by the Central Zoo Authority (CZA) for seeking Funds in accordance with Section 5 (b) (iii) of CAF Act.

Proposal 1: Formulating an integrated species recovery plan for threatened species - Rs 100 crores.

Proposal 2: Setting up national referral centre for wildlife disease monitoring and prevention- Rs 3 crores for first year.

Decision: The Executive Committee considered the two proposals of CZA forwarded by the Wildlife Wing of MoEF&CC, and recommended them as schemes (Section 5(b) (iii) of CAF Act, 2016) for the approval of the Governing Body of the National Authority as per the provision contained in Section 14(1) (iv) of the CAF Act, 2016 with following suggestions:

- i. The basis of cost estimation shall be submitted
- ii. The mid-term review shall be done by independent experts
- Monitoring and implementation of the proposal shall be the responsibility of Wildlife Division of MoEF&CC.
- iv. There should not be any duplication with the schemes being implemented by Wild Life Institute of India or Wildlife division.

Additional Agenda Item with Permission of the Chairman, Executive Committee

Dy DGF, Regional Office, MoEF&CC, Ranchi informed that the States are not depositing the funds recovered/recoverable from user agencies under different sections of Wildlife (Protection) Act for undertaking activities relating to the protection of biodiversity and wildlife in the State Fund as provided in Section 4 (3)(iv) and Section 6 (d) of CAF Act, 2016. It was decided that States/UTs shall be requested to look into this matter, take necessary measures and furnish the information to the National Authority within one month under intimation to the Regional Offices.
