- x The User Agency shall obtain the Environmental Clearance before issue the formal order, if applicable.
- xi All statutory provisions under various Acts, Rule there under and guidelines applicable to this project shall be strictly adhered to.
- xii All the fund received from the User Agency under the project shall be transferred to the Ad-hoc Compensatory Afforestation Fund Management & Planning Agency (CAMPA) in Saving Bank designated by Government of India.
- xiii The forest land shall not be used for any purpose other than that specified in the proposal.

Dear Sir,

Gujarat Gas Limited (GGL) is the company owned by the Government of Gujarat engaged in process to set up Piped Natural Gas (PNG) distribution network in all major Cities, District/Taluka Headquarters in entire Gujarat State. PNG is an eco-friendly gas and an alternative of Kerosene /LPG.

Gujarat Gas Limited is in process to set up gas distribution network in the entire South Gujarat Region. Wherein we have already connected Major Cities like Navsari, Gandevi, Chikhli, Vapi, Valsad, Umargam, Bhilad & Sarigam for domestic & commercial use only. Now we are in process to connect other cities and surrounding areas of Dadra & Nagar Haveli (U/T). The proposed pipeline will be laid in the space available alongside the roads at a depth of at least 1.2 meter below the finished ground level. Company shall follow all the best standards of safety as prevailing in Gas distribution industries.

Details of pipeline laying parallel & across to SH /Asphalted Roads which has been declared as Protected Forest are furnished in **Anneuxure-A**.

For laying purpose 0.4 mtr. width of forest strip is proposed for the pipeline parallel & across to various roads like State Highway & Asphalted Roads in Dadra and Nagar Haveli. With this provision of 0.4 mtr width and 9561 mtr. Length is required for parallel to State Highway / Asphalted Roads.

Total 0.3824 Hect. of area is required in protected forest for pipeline laying parallel & across to the State Highway & Asphalted Roads at various locations in Dadra and Nagar Haveli (U/T). It is stated here that the road side strip forest through which the pipeline across to the road is taken in such a way that minimum tree cutting is involved. For other areas, which are not been declared as protected forests, a separate proposal is being submitted for seeking permission for cutting of trees if any, obstructing the pipeline route.

The forestlands as identified by us are included in the application. However, if any area is left out, the same may please be included. The route map of above said parallel and crossing Gas Distribution Network is enclosed herewith for your reference.
