Out of this amount of Compensatory Afforestation including contingencies charges **Rs. 32,71,384/-** has been deposited with Adhoc CAMPA and balance amount of **Rs.5,45,397/-** towards Departmental charges has been deposited in the Govt.Treasury.
 2. The user agency has deposited **Rs. 80,63,940 /-** towards NPV.
 3. Undertaking to pay the additional amount of NPV submitted by the user agency is enclosed.
