BINJABAHAL TO TELEBANI FOREST DIVERSION PROPOSAL NO.FP/OR/ROAD/18864/2016, STATE SL. NO. OR-032/2016 DT. 02.05.2016

I, the DGM(Tech.) & Project Director, on behalf of NHAI, PIU, Keonjhar, hereby undertake to comply the following conditions as stipulated in Stage-I order vide No. 5-ORA329/2017-BHU Dt.15.01.2018 by MoEF & CC, GOI:

- 1. That the legal status of land proposed for diversion will remain unchanged.
- 2. That the additional amount of NPV, if so determined, at the present rate, as per the final decision of the Hon'ble Supreme Court of India shall be paid by National Highways Authority of India, PIU, Keonihar.
- 3. To facilitate wildlife movement and suggested by Chief Wild Life Warden, Odisha the new 51(Fifty one) nos. of additional crossing from existing 28 nos. will be constructed.
- 4. After 5(Five) years Site Specific Wildlife Conservation Plan will be revised and will pay the revised cost of conservation plan till the project period.
- 5. If there would be need for Site Specific Wildlife Conservation Plan after expiry of the present plan period, will submit the Site Specific Wildlife Conservation Plan for the next 10(Ten) years one year before the expiry of the present SSWLCP and will deposit the outlay amount upon its approval.
- 6. Will pay the differential cost in case of enhanced wage rate at the time of implementation of Site Specific Wildlife Conservation Plan.
- 7. Will not to collect any toll tax from the vehicles registered under Forest Department
- 8. Will pay the cost of demarcation of diverted forest land if so determined in future and will deposit with DFO-Deogarh.
- 9. No tree will be cut in case the widening of the road in area already having adequate clearance. If any tree to be fell will be done under supervision of the State Forest Department.
- 10. The designing of culverts/bridges, over the natural streams/ rivers/ canals will be done in such a manner that it will not hamper the natural course of water, does not give rise to water-logging, and also does not hamper movement of wild animals.
