

## COMPLIANCE REPORT FOR OBTAINING STAGE-2 FOREST CLEARANCE

(Proposal no: FP/KL/Others/20218/2016 dated 27 June 2016)

1.	The legal status of deemed forest land shall remain unchanged.	The legal status of deemed forest land will remain unchanged
2.	The demarcation of the deemed forest area being diverted shall be carried out at the cost of User Agency, before Stage-II approval.	<p>The total project area is 16.9 ha. Out of which, 0.01866 ha i.e., (186.6 M<sup>2</sup>) occupied by 15 nos. mangrove plants is identified as deemed forest area. These mangroves have grown due to siltation near to the slipway area where quay wall is not present. As per the master-plan, workstations for ship repair will be constructed in this area. Hence 15 nos. mangrove plants need to be felled. In view of the above, it may be noted that demarcation of the deemed forest area (186.6 M<sup>2</sup>) is not practically possible.</p> <p>However as a compensatory measure, 2 ha of mangrove afforestation is being carried out by Cochin Shipyard Limited at Munroe Thuruth, Kollam in association with Panchayat &amp; Social Forestry Dept of Kerala. Resolution passed by Panchayat in this regard is placed as <b>Encl: 1</b>.</p>
3.	The cost of raising plantation of 10 times the number of trees to be felled shall be deposited by the user agency.	As per the Demand letter issued by Divisional Forest Officer (DFO), Rs. 12,000/- was deposited in the Kerala CAMPA account towards compensatory afforestation on 23 Aug 2017. Copy of the demand letter issued by DFO is placed as <b>Encl: 2</b> and payment details are placed as <b>Encl: 3</b> .
4.	The State Government shall charge the Net Present Value of the diverted deemed forest land measuring 0.01866 ha. From User Agency as per the orders of the Hon'ble Supreme Court dated 28.03.2008 and 09.05.2008 in IA Nos.826 in 566 with related IA's in Writ Petition (Civil) No.202/1995.	As per the Demand letter issued by DFO ( <b>Encl: 2</b> ), Rs. 17,522/- as NPV in lieu of the diverted deemed forest land of 0.01866 ha was deposited in the Kerala CAMPA account on 23 Aug 2017. Refer <b>Encl: 3</b> for the payment details.
5.	Additional amount of the Net Present Value (NPV) of the diverted deemed forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from User Agency. User Agency shall furnish an undertaking to this effect.	An undertaking by CSL in this regard was submitted to DFO on 01 Aug 2017. Copy of the undertaking submitted is placed as <b>Encl: 4</b> .





6.	The User Agency shall make online payment of cost of Compensatory Afforestation and Net Present Value with Adhoc-CAMPA through e-payment module of Forest Clearance portal- forestclearance.nic.in.	Net present value (NPV) of Rs.17,522/- and cost of compensatory afforestation Rs.12,000/- have been paid with Adhoc- CAMPA through e-payment module of Forest Clearance portal.  Challan was generated on 17 Aug 2017 ( <b>Encl: 5</b> ) followed by remittance of payment on 23 Aug 2017.Refer <b>Encl: 3</b> for the payment details.
7.	Necessary certificates/documents under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act 2006 as per the guidelines issued by Ministry of Environment & Forests vide letter No.11-9/1998-FC (Pt) dated 05.07.2013 shall be furnished before Stage-II clearance.	Copy of certificate issued by District Collector, Ernakulam in this regard is placed as <b>Encl: 6</b> .
8.	All other approvals required under different Acts shall be obtained before commencement of the project.	CSL application for wild life clearance (FP/KL/Others/747/2016) was recommended by Kerala State Board of Wild Life (SBWL) after deliberation in its meeting held at Thiruvananthapuram on 16 Aug 2017 and is presently awaiting deliberations at the forthcoming NBWL meeting tentatively scheduled in the first week of Nov 2017. All other statutory approvals have been obtained already.
9.	The total deemed forest area utilized for the project shall not exceed 0.01866 ha.	Noted.
10.	Any other condition that the Additional Principal Chief Conservator of Forests (Central), Regional Office, Bangalore may impose from time to time for protection, improvement of flora and fauna in the forest area and public convenience, shall also be applicable.	Noted and will be complied.
11.	Violation of any of the conditions shall invite penal action, as deemed fit by the Additional Principal Chief Conservator of Forests (Central), Regional Office, Bangalore.	Noted.



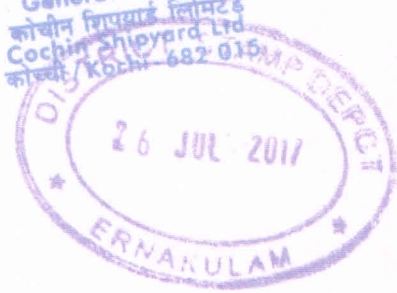
