
With reference to letter No. F.No. GOB1100/2016-BAN/1065 dated 28th November 2016 on the above cited received from MOEF &CC, Regional Office, Bangalore and your letter No. 5/FCA-133/MOPA-Air/PER/DCFN/TECH/ 2015-16/720 dated 30/12/2016 the compliance report on the conditions stipulated therein is given below for further necessary action at your end.

1	The legal status of forest land shall remain unchanged.	This is to confirm that the legal status of forest shall remain unchanged.
2	Demarcation of the proposed forest area shall be carried out by erecting cement concrete pillars duly numbered at an interval of 20 mts at the cost of user agency before Stage-II clearance.	Complied
3	The cost of raising Plantation of ten times the number of trees to be felled (72 trees to be felled x 10) shall be realized from the user agency.	The Department of Forests, Government of Goa vide letter No. 5/FCA-133/MOPA-Air/PER/DCFN/TECH/ 2015-16/720 dated 30/12/2016 received in the Directorate of Civil Aviation on 20/2/2017 informed to make payment of Rs.72,000/- towards cost of raising 72 x 10 Nos of Forestry species @ Rs.100 per species and Rs.1,06,388.70 towards NPV @ Rs. 9,39,000 for canopy density 0.5 by Electronic Transfer (RTGS)

6	The User Agency shall make online payment of cost of Compensatory Afforestation and Net Present Value with Adhoc - CAMP A through e-payment module of Forest Clearance portal - forestclearance.nic.in	As mentioned at Sl.No. 3 & 4 above online payment has been made as per instructions of the Department of Forests, Government of Goa by NEFT.
7	The total forest area utilized for the project shall not exceed 0.1133 ha.	Agreed
8	Any other condition that the Additional Principal Chief Conservator of Forests (Central), Regional Office, Bangalore may impose from time to time for protection, improvement of flora and fauna in the forest area and public convenience, shall also be applicable.	Agreed
9	Violation of any of the conditions shall invite penal action, as deemed fit by the Additional Principal Chief Conservator Forests (Central), Regional Office, Bangalore.	Agreed
