Subject:- Allotment of Gram Sabha land measuring 36 Bigha 05 Biswa in Village Rawta, District South-West in lieu of diversion of protected forest land allotted by DDA to Transport Department at East Vinod Nagar for bus depot

Sr,

1. The DDA had earlier allotted a piece of land measuring 18396.96 sq. meters to the Transport Department for construction of Cluster Bus Depot at East Vinod Nagar. The proposal of the Transport Department to construct the said bus depot at East Vinod Nagar was approved by the Expenditure Finance Committee (EFC) through Public Works Department ("PWD") on Depot work basis on 07.02.2018. The PWD called tender for construction of bus depot on the said land. However, it transpired that the said parcel of land was a part of a Reserve Forest when the Transport Department vide a letter dated 18.07.2018 and 22.10.2018 to the concerned Deputy Conservator of Forest sought permission for felling of 75 numbers of Eucalyptus Trees on the said land. In response, it was informed by Forest Department vide its letter dated 11.12.2018 that the area in question was protected forest land and as such, a proposal for diversion of the said forest area was required to be made under the Forest Conservation Act, 1980 to the Ministry of Environment, Forest & Climate, Regional Office (Central Region) Lucknow.
2. Accordingly, the said approval was obtained from the Regional Office at Lucknow. The permission was thus granted vide communication dated 19.07.2019 for the "diversion of 1.84 ha of protected forest land for construction of cluster bus depot at East Vinod Nagar by the Transport Department, GNCTD". The said approval was however, subject to compensatory afforestation being taken up by the forest department over an equivalent area of non-forest land. It was further mandated that "non-forest land shall be transferred and mutated in favour of the said forest department." Copy of the said letter dated 19.07.2019 is annexed hereto and marked as Annexure - I.
3. A portion of land measuring 37 bigha 10 biswa in Village Malikpur, which was allotted to the Transport Department by the Panchayat Department vide allotment letter dated 24.09.2008 was considered for compensatory afforestation. Thus, on 19.02.2019 a request

was made to the Director (Panchayat) for the said allotment. Later, a reminder dated 29.07.2019 was sent to seek approval of the Hon'ble Lt. Governor to allot an equal area measuring 18396.96 sq. meters with a map enclosed therewith from the aforesaid parcel of the land of village Malikpur, District South West to the Forest Department, Government of NCT of Delhi on perpetual basis for compensatory afforestation. It was, however, informed that since Village Malikpur stood urbanized, the said Gram Sabha Land had been placed at the disposal of the DDA vide notification dated 28.01.2019 of Ministry of Housing and Urban Affairs, Government of India. The Transport Department was thus advised to take up the matter with the DDA. Accordingly, the Panchayat Department addressed a letter dated 23.08.2019 to the DDA requesting for allotment of the said Gram Sabha land measuring 21 Bighas 16 Biswa from the Transport Department to the Forest Department for compensatory afforestation. The Transport Department also made a similar request to the DDA by a letter dated 16.10.2019. The BDO (HQ), Revenue Department vide his letter dated 24.08.2020 again reiterated the request to the DDA for allotment of the Gram Sabha land in village Malikpur to the Forest Department, GNCT of Delhi.

4. Since, no permission was forthcoming from the DDA regarding the Malikpur parcel of land, the Revenue Department, Government of NCT of Delhi was requested to allot 18396.96 square meters of Gram Sabha land directly in the name of Forest Department, Government of NCT of Delhi in lieu of diversion of protected forest land allotted by DDA to Transport Department at East Vinod Nagar for bus depot.

5. Director (Panchayat), Government of NCT of Delhi vide his letter bearing No.17(02)/BDO/SW/NG/2021-22/1604-1617 dated 03.11.2021 addressed to Pr. Chief Conservator of Forest, Department of Forests and Wildlife, Government of NCT of Delhi on the aforementioned subject (copy of which was also endorsed to Commissioner, Transport) has informed that Hon'ble Lieutenant Governor, Delhi has conveyed his approval for allotment of Gram Sabha Land measuring 36 Bigha 05 Biswa in Village Rawata, District South-West in lieu of diversion of protected forest land allotted by DDA at East Vinod Nagar for bus depot. The Khasra Numbers and the terms & conditions of allotment are mentioned in the aforesaid letter. Copy of the said communication is enclosed herewith for your ready reference as Annexure - II.

6. The Deputy Conservator of Forest, North Forest Division/Tree Officer, Department of Forest & Wildlife, vide his letter dated 25.07.2019 (copy enclosed for ready reference as Annexure - III) has referred the letter dated 19.07.2019 from AIG Central, MoEF&CC, Lucknow and invited the attention of Transport Department on the following points:-

- (i) You are hereby directed to submit the compliance of the terms and conditions from S.No.3 to 16, as mentioned in the letter dated 19.07.2019 conveying Stage - 1/In-Principal approval.
- (ii) With respect to Point No.2 & 3, you are requested to transfer 1.84 ha. of non-forest land identified for compensatory afforestation at Malikpur to Deputy Conservator of Forests, West Forest Division which shall be mutated in favour of Forest Department. For land transfer, you are requested to coordinate with DCF West (contact number - 8800873022).
- (iii) With respect to Point No.4 regarding the cost of compensatory afforestation at the prevailing wage rates it is informed that you shall deposit an amount of Rs.1,45,40,370/- (Rupees One Crore Forty Five Lakh Forty Thousand Three Hundred & Seventy only), which include the cost of creation of plantation of 2045 saplings, their maintenance for 10 years and anticipated cost increase @ 7.5%.

With respect to Point No.5, it is informed that the Net Present Value (NPV) for 1.84 ha. of forest area to be diverted amounts to Rs.11,51,840/- (Rupees Eleven Lakh Fifty One Thousand Eight Hundred & Forty only).

You are requested to deposit both cost for compensatory afforestation and Net Present Value (NPV) to CAMPA Fund through e-portal (<https://parivesh.nic.in>).

You are hereby directed to submit the compliance of aforesaid conditions at the earliest to this office which has to be forwarded to MoEF&CC, Regional Office, Central Region, Lucknow for obtaining Stage-II approval.


7. Accordingly, Transport Department now depositing the aforesaid amount of Rs.1,45,40,370/- and Rs.11,51,840/- in compliance of the directions of AIG Central, MoEF&CC, Lucknow and Deputy Conservator of Forest, North Forest Division/Tree Officer, Department of Forest & Wildlife, for diversion of 1.84 ha. of forest area at East Vinod Nagar.

8. In view of the above, I am directed to request to the Forest Department and Director (Panchayat) of Government of NCT of Delhi to immediately initiate the following processes:-

- (i) Forest Department may kindly process the applications of this department dated 18.07.2018 and 22.10.2018 (photocopies enclosed) regarding permission for felling of 75 numbers of Eucalyptus Trees on the land parcel located at East Vinod Nagar.
- (ii) The Director (Panchayat) may kindly mutate the Gram Sabha land measuring 36 Bigha 05 Biswa in Village Rawta, District South-West in lieu of diversion of protected forest land allotted by DDA to Transport Department at East Vinod Nagar for bus depot in favour of Forest Department in coordination with DCF West (contact number - 8800873022).
