

I am directed to refer to the State Government's letter No. FEE 145 FGL 2017 dated 09/02/2018, 22.10.2018, 30.01.2020, 14.05.2020, 25.11.2021 and proposal received online through Parivesh Portal on 01.03.2025 seeking prior approval of the Central Government under Section '2(1)' of Van (Sanrakshan Evar Samvardhan) Adhiniyam, 1980 for the above project.

Further, it may also be noted that this in-principle approval shall be valid for a period of 2 years from the date of issue of this letter. In the event of non-compliance of the above conditions within 2 years, the in-principle approval shall be deemed to be null and void.






