## UNDERTAKING

The 'In-Principle Approval' for diversion of 4.563 ha of forest land for construction of 132kV Agia- Chibinang - Hatsingimari Transmission Line was received by Assam Electricity Grid Corporation Limited (AEGCL) vide Government of India letter No. 3-MGB-111/2019-SHI/3379-80 dated 29-01-2021 from the Deputy Inspector General of Forest ( C ), Ministry of Environment Forest & Climate Change, Regional Office, Shillong .

In this connection, along with the 'In Principle approval' certain conditions were mentioned which were needed to be strictly complied by AEGCL on field after handing over the forest land by the State Forest Department. A compliance in the form of undertaking on behalf of AEGCL has been certified by the undersigned for the below mentioned points for Stage-II approval.

1. AEGCL certifies that legal status of the forest land shall remain unchanged.
2. AEGCL certifies that compensatory afforestation will be raised with mixed species for plantation in the land designated by the Forest Department.
3. NPV amount has already been paid.
4. AEGCL certifies that felling of trees has been restricted to the minimum in the diverted forest land and the cost of felling of trees has been paid to DFO, West and South West Garo Hills(T) Division, Tura
5. AEGCL in consultation with the state forest department shall prepare a detailed scheme for creation and maintenance of plantation of dwarf species in right of way under the transmission line for execution of the said scheme by the State Forest Department.
6. AEGCL at its cost will provide bird deflectors which are to be fixed on upper conductor of transmission line at suitable intervals to avoid bird hits.
7. AEGCL will comply with the guidelines for laying transmission line through forest areas issued by Ministry vide letter no. 7-25/2012-FC dated 05/05/2014 & 19/11/2014.
8. AEGCL will obtain the Environmental Clearance under Environment (Protection) Act, 1986 , if applicable.
9. AEGCL will not change the layout of the proposal without the prior approval of the Central Government.
10. AEGCL will not establish any labour camps on the forest land.
11. AEGCL will provide sufficient firewood to the labourer after receiving the approval for constructing transmission line from State Forest Department.
12. AEGCL will not construct any additional or new path inside the forest area for transportation of construction materials for execution of the project work.
13. AEGCL acknowledges that the period of diversion under this approval will be co-terminus with the period of lease or the project life, whichever is less.
14. AEGCL will not use the forest land for any purpose other than that specified in the project proposal.
15. AEGCL will provide necessary lopping so that lines shall have no contact with trees.

16. AEGCL certifies that sagging of power lines from pole to pole shall not come in contact with any wildlife specifically Asian elephants considering height as they out reach their trunk.
17. AEGCL will use AAAC9 all aluminium alloy conductor of panther specification in the 132KV Line which will not do harm to any wildlife in the proposed area.
18. AEGCL certifies that the forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without the prior approval of Govt. of India.
19. AEGCL will follow any other conditions that the North Eastern Regional Office, Ministry of Environment Forest & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
