In reference of above cited subject, the Central Government vide letter under ref (1) (copy enclosed) conveyed the **"In-Principle Approval"** for diversion of 54.933 ha of forest land for construction of two-lane with paved shoulder of Old Tamenglong-Phelong Section (Package-3) from km 31.430 to km 43.480 of Tamenglong-Mahur Road in the State of Manipur on EPC Mode.

Further, the State Forest Department issued us a demand note for payment of NPV, CA cost, etc. & for compliance of stipulated conditions given in IPA vide letter under ref (2,4,5 & 6) (copy enclosed) for Stage-II Clearance. 


Erection of Permanent Survey Pillars
