The Govt of India, Ministry of Environment & Forests, Regional Office, Bhubaneswar vide Letter No 5-ORB432/2020-BHU dated 05-11-2020 accorded "In-Principal" (stage-I) approval for diversion of 1.3841 H a. of Forest land for construction of diversion portion of 400 KV Double Circuit Talcher – Meramundali Transmission line from Location No- 29 to 32 for proper crossing of Talcher-Bimlagarh Railway Line, East Coast Railway by Power Grid Corporation of India Ltd subject to fulfillment of conditions prescribed therein. The point wise compliance are furnished below.

Condition No-(i): Legal status of Forest land shall remain unchanged.

Condition No-(ii): Forest land will be handed over only after required non-forest land for the project is handed over to the user agency.

Condition No-(iii): Compensatory Afforestation shall be taken up by the State Forest Department over 2.7682 Ha of degraded forest land identified in Paranga RF under Angul Range of Angul Forest Division at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted using multi species, multi canopy intensive planting technique and monoculture of any species shall be avoided. A revised C.A. Scheme consisting of indigenous species to result in a multi canopy forest may be submitted before stage-II approval.

In compliance to the above, Compensatory Afforestation Scheme has already been approved by competent authority with financial outlay of Rs 5,23,100.00.

Condition No-(iv): *The cost of Compensatory Afforestation at the prevailing wage rate as per Compensatory Afforestation scheme and at the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.*

S.O. 1533(E).—Whereas, a draft notification under Sub-rule (3) of Rule 5 of the Environment (Protection) Rules, 1986 for imposing certain restrictions and prohibitions on new projects or activities, or on the expansion or modernization of existing projects or activities based on their potential environmental impacts as indicated in the Schedule to the notification, being in any part of India¹, unless prior environmental clearance has been accorded in accordance with the objectives of National Environment Policy as approved by the Union Cabinet on 18th May, 2006 and the procedure specified in the notification, by the Central Government or the State or Union Territory Level Environment Impact Assessment Authority (SEIAA), to be constituted by the Central Government in consultation with the State Government or the Union Territory Administration concerned under Sub-section (3) of Section 3 of the Environment (Protection) Act, 1986 for the purpose of this notification, was published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (ii) vide number S.O. 1324(E), dated the 15th September, 2005 inviting objections and suggestions from all persons likely to be affected thereby within a period of sixty days from the date on which copies of Gazette containing the said notification were made available to the public;

2. **Requirements of prior Environmental Clearance (EC):**— The following projects or activities shall require prior environmental clearance from the concerned regulatory authority, which shall hereinafter referred to be as the Central Government in the Ministry of Environment and Forests for matters falling under Category 'A' in the Schedule and at State level the State Environment Impact Assessment Authority (SEIAA) for matters falling under Category 'B' in the said Schedule, before any construction work, or preparation of land by the project management except for securing the land, is started on the project or activity:

- (i) All new projects or activities listed in the Schedule to this notification;
- (ii) Expansion and modernization of existing projects or activities listed in the Schedule to this notification with addition of capacity beyond the limits specified for the concerned sector, that is, projects or activities which cross the threshold limits given in the Schedule, after expansion or modernization;
