Post facto approval of cluster concept of environmental clearance along with Feasibility reports of the collieries submitted to MOEF for grant of environmental clearance.

Background:

BCCL had applied for obtaining environmental clearances for all its mines from 2008 onwards. However, MoEF had suggested BCCL to prepare EIA/EMPs for obtaining environmental clearances under the "Cluster Concept", for which BCCL formulated a Cluster Concept grouping all its 103 mines (including abandoned and proposed) into 17 Clusters. However, the environment clearance based on cluster concept was obtained without getting formal approval of the BCCL Board. Hence, the proposal has been mooted now.

Decision:

After detailed deliberation Board accorded **post facto** approval to cluster concept formulated by CMPDI for obtaining environmental clearances, along with Feasibility Reports of Clusters of mines submitted to **MoEF** as listed and enclosed with the agenda note as Annexure-F.

Subject: Post facto approval of cluster concept of environmental clearance along with Feasibility reports of the collieries submitted to MOEF for grant of environment Clearance.

(A) BACKGROUND and STATUS OF ENVIRONMENTAL CLEARANCES FOR BCCL MINES:

As all the mines of BCCL are taken over mines from the erstwhile private owners and are more than 100 years old, proper and structured project reports/EIA-EMPs were not present and were also not required as per the EIA Notification 1994. Thus environmental clearances were not there for BCCL mines. However the EIA Notification, 2006 and modified in April, 2011 attracted the preparation of EIA/ EMPs and obtaining environmental clearances for all mines including old mines and also renewal of mining leases. Following this, BCCL had applied for obtaining environmental clearances for all its mines from 2008 onwards. However, MoEF had suggested BCCL to prepare EIA/ EMPs for obtaining environmental clearances under the "Cluster Concept", for which BCCL formulated a Cluster Concept grouping all its 103 mines (including abandoned and proposed) into 17 Clusters. MoEF had approved this Cluster Concept in Dec., 2009 and then onwards MoEF approved the TORs for all the 17 Clusters and granted environment clearance to 16 Clusters covering all mines of BCCL located in Jharkhand. In addition, environmental clearances for three proposed coal washeries i.e. Patherdih 5 MTPA, Madhuban 5 MTPA & Patherdih 2.5 MTPA Coal Washeries have been granted by MoEF.

Approval of cluster concept & present EC status is enclosed as Annexure-A.

(B) PROCESSING EC APPLICATION

As provided in EIA Notification 2006,

6. Application for Prior Environmental Clearance (EC):-

An application seeking prior environmental clearance in all cases shall be made in the prescribed Form 1 annexed herewith and Supplementary Form 1A, if applicable, as given in Appendix II, after the identification of prospective site(s) for the project and/or activities to which the application relates, before commencing any construction activity, or preparation of land, at the site by the applicant. The applicant shall furnish, along with the application, a copy of the pre-feasibility project report except that, in case of construction projects or activities (item 8 of the Schedule) in addition to Form 1 and the Supplementary Form 1A, a copy of the conceptual plan shall be provided, instead of the pre-feasibility report.

Copy of EIA notification-2006 is enclosed as annexure-B.

Subsequently, a copy of instructions issued by Ministry of Environment & Forest regarding Environment Clearance application submission & consideration of coal Sector Projects was circulated by CGM,CIL,New Delhi vide CIL/DLI/CGM/2008/94/884 dated Sept 19,2008(Enclosed as Annexure-C). Some of instructions are:

- 6. The application (Form-I and the pre-feasibility report) should be photocopied back to back while submitting to the Ministry and while circulating to EAC Members.
- 8. A CD (soft form) of TOR application containing the Form-I and the pre-feasibility report) should be submitted to the Ministry and to EAC Members at the time of circulation.
- 11. **In case of new projects**, it is desirable to submit applications for TOR when the mining Plan is under finalisation/draft stage, the details of which can be provided in the pre-feasibility report.

CMPDI submitted proposal for preparation of EIA/EMP (with breakup of activities) accordingly vide CMPDI/RI-II/ENV.M-30/3601-02 dated 01.12.2008 which was approved and communicated to CMPDI,RI-II on 31.0.2009.

Copy of CMPDI proposal & communication of approval is enclosed as Annexure-D.

The Feasibility reports prepared by CMPDI confirms to Guideline(No.-J11013/41/ 2006-IA.II.(I) dated 30th Dec 2010) issued by MOEF for preparation of pre-feasibility report for obtaining prior environmental clearance in terms of the provisions of EIA notification 2006.

Copy of MOEF guideline is enclosed as annexure -E.

(E) NECESSITY AND JUSTIFICATION OF THE MATTER:

To expedite environment Clearance Form-I application was made on cluster basis along with feasibility report of the collieries/projects since Mining Plans were neither available nor there was sufficient time available to prepare. Further MOEF did not raise any demand for approved mining plan while granting EC, before Cluster-XII (Proposed Kapuria UG) & enhancement proposal of Cluster-IV. For grant of EC, the Feasibility Reports signed by Director were submitted. As per requirement of MOEF, a formal resolution by BCCL Board of Directors to ensure that violations of the Environment (Protection) Act etc. will not be repeated (288th Board on 31.07.2012) was also submitted. In the said Board meeting & subsequent informations provided to Board on environment management, information on obtaining environment clearance based on cluster concept provided but formal approval was not obtained.

Now EC for 16 clusters are granted and to regularise the procedure for facilitating future expansion applications, post facto approval of BCCL Board is sought for

- 1. Cluster concept formulated by CMPDI for obtaining environmental Clearances
- 2. Feasibility Reports of Clusters of mines submitted to MOEF as listed and enclosed as Annexure-F

(G) MATTER FOR BCCL BOARD'S APPROVAL:

BCCL's Board of Directors may kindly accord post facto approval to

- 1. Cluster concept formulated by CMPDI for obtaining environmental Clearances
- 2. Feasibility Reports of Clusters of mines submitted to MOEF as listed and enclosed as Annexure-F
