Read:

Application presented on 4.12.75 by M/s Orissa Mining Corporation Ltd. for grant of a Mining lease for Iron and Manganese over an area of 1331.20 Acres or 538.61 hecteres in the district of Keon Jhar.

ORDER

Whereas M/s Orissa Mining Corporation Limited have applied to the State Government for grant of a Mining lease by its application read above :

Whereas the mineral in the land in respect of which the mining lease has been applied for belongs to Government and the land is at their disposal;

Whereas the applicant holds a valid certifica to of Approval from the State Government;

Whereas the applicant being a limited company is incorporated in India

Whereas the Government of India have conveyed their approval to the grant of Mining lease under section 5(2) of the Mines and Minerals(Regulation and Development) Act, 1957 and also in exercise of the powers conferred by section 30 of the said Act, directed the State Government to take into consideration this application and pass orders thereon;

Whereas the Govt. of India in exercise of powers conferred under the provision to section 6(1)(b) of the M & M(R&D) Act, 1957 have authorised the State Government to grant mining lease over the area of 1.03 sq.miles i.e. the western half of the original lease hold area of M/s Bird & Co. in excess of the prescribed limit of 10 sq.km. to M/s D.M.C. Ltd.;

Whereas the Govt. of India in exercise of powers conferred under subrule (2) of rule 59 of the M.C.Rules, 1960 have authorised the State Government to grant M.L. over the aforesaid area of 1.03 sq.miles to M/s O.M.C.Ltd. withou following procedure laid down in sub-rule (1) of the said rule -59;

Whereas the party was asked in M & G Department letter No. 1603 MG dt.5.2.85 to accept the terms and conditions under which the Mining lease was proposed to be considered for grant and the party in his latter No. 2941/0 MC/85 dt.13.2.85 accepted these conditions;

Therafore, the State Government are hereby pleased to order that a Mining lease in respect of the land over 1.03 sq.miles i.e. the western half of original leased area of 2.06 sq.miles of M/s Bird and Co. be granted to M/s OMC W for a period of 20 years with effect from 7.3.76 subject to the conditions laid down in the State Government letter No. 1603/MG dated 5.2.85 . The party should comply with all the terms and conditions including furnishing of a surveyed map and description within 3 months from the date of this order to the Collector , Keonjhar .
