Sub: Diversion of 1.6022 ha forest land in favour of National Highway Authority of India, PIU-I for bypass of Nagpur-Bhandara road section of NH-53 (Old NH-6) Package between chainage 485.00 to 499.800 in Tal & District Bhandara in the State of Maharashtra- regarding.

Sir.

The undersigned is directed to refer to APCCF & Nodal Officer (FCA), Maharashtra's letter No. Desk-17/NC/I/ID-/1201/20-21 dated 10.02.2021 on the above subject seeking prior approval of the Central Government under Section-2 of the Forest (Conservation) Act, 1980 and to say that the said proposal has been examined in the Integrated Regional Office in light of the relevant provisions of the Forest (Conservation) Act, 1980 and Guidelines issued thereunder.

After careful examination of the proposal and on the basis of the recommendation of APCCF & Nodal Officer (FCA), Maharashtra, the Central Government hereby accords 'inprinciple' under Section - 2 of the Forest (Conservation) Act, 1980 for diversion of 1.6022 ha forest land in favour of National Highway Authority of India, PIU-I for bypass of Nagpur-Bhandara road section of NH-53 (Old NH-6) Package between chainage 485.00 to 499.800 in Tal & District Bhandara in the State of Maharashtra subject to the fulfilment of the following conditions

i. Legal status of the forest land shall remain unchanged;

ii. Compensatory afforestation

- a) Compensatory afforestation shall be taken up by the Forest Department over 3.21 ha. degraded Forest land in Comptt. No. 96 PF, Survey No. 46, 47 at Village Saleheti (Hamesha), Tal. & Dist- Bhandara at the cost of the User Agency. As far as possible, a mixture of local indigenous species along with 10% RET species of Bhandara District shall be planted and monoculture of any species may be avoided.
- iii. The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars on the CA land and fencing from boundary of forest land to protect narrow left over patch shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years

iv. NPV:

- a) The State Government shall charge the Net Present Value (NPV) for the 1.6022 ha forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009 in this regard;
- b) Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect;
- v. User agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department;
- vi. All the funds received from the user agency under the project shall be transferred/deposited to CAMPA fund only through *e-portal* (https://parivesh.nic.in/);
- vii. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector;
- viii. To improve the Forest/ Tree cover and to reduce pollution, as mandated in National Forest Policy, 1988 and Environmental (Protection) Act, 1986 respectively, the User Agency shall develop a separate nursery at one or more places to raise at least 5,000 seedlings of forestry species along with bamboo, fruit bearing, medicinal, ornamental and indigenous/local every year. At least 50% of seedlings shall be planted by User Agency in the vicinity of project area including forest area and for hand holding with local people residing in vicinity of proposed road, User Agency shall voluntary distribute remaining 50% of seedlings to them free of cost. A compliance report including species wise details of seedlings raised, location of plantation area and details of villagers whom seedlings have been distributed need to be prepared every six month and submitted to Regional Office of MoEF&CC;
- ix. State Forest Department shall undertake avenue plantation as per IRC norms at the cost of User Agency;
- x. Speed regulating signage will be erected along the road at regular intervals in the Protected Areas/ Forest Areas;
- xi. The User Agency shall provide suitable under/ over pass for safe passage of wild animals at suitable places as per Wildlife Institute of India's manual entitled "Ecofriendly Measures to Mitigate Impacts of Linear Infrastructure on Wildlife" published in 2016;
- xii. Permission from National Board for Wildlife may be obtained if the same has not been obtained by the User Agency for area falling within Eco-sensitive Zone of Navegaon Nagzira Wildlife Sanctuary. Copy of the same shall be submitted along with Stage-I compliance report;
- xiii. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable;

- xiv. The layout plan of the proposal shall not be changed without prior approval of Central Government;
- xv. No labour camp shall be established on the forest land;
- xvi. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel;
- xvii. The User Agency in consultation with the State Government shall create and maintain alternate habitat/home for the avifauna, whose nesting trees are to be cleared in this project. Bird's nests artificially made out of eco-friendly material shall be used in the area, including forest area and human settlements, adjoining the forest area being diverted for the project;
- xviii. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer;
 - xix. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work;
 - xx. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less;
 - xxi. The forest land shall not be used for any purpose other than that specified in the project proposal;
- xxii. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India;
- xxiii. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018;
- xxiv. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife;
- xxv. The compliance report shall be uploaded on e-portal (https://parivesh.nic.in/);

After receipt of a report on the compliance of conditions no iii, iv (a), v, vi, vii, xii and undertakings, duly authenticated by the competent authority in the State Government, in respect of all other conditions, from the State Government, formal approval will be considered in this regard under Section-2 of the Forest (Conservation) Act, 1980.

This issues with the approval of Regional Officer (Central), Integrated Regional Office, MoEF & CC, Nagpur.
