ORDER

In pursuance of the guidelines issued by the Ministry of Environment & Forests, Government of India, referred above, an in-principle approval was given for diversion of 0.9756 Ha. of Protected forest land for laying of underground Natural Gas Pipeline parallel and across roads and canalside of village Naroli in the U.T. Dadra & Nagar Haveli to M/s. Gujarat Gas Limited, Gandhinagar vide office letter No. (vi) above.

The User Agency has complied the conditions imposed in the in-principle approval. The condition No. (v) has been complied by effecting the payment of ₹ 19,36,488/- (Rupees: Nineteen Lakh Thirty-six Thousand four hundred and eighty-eight only) towards Compensatory Afforestation (it includes cost of Compensatory Afforestation, Fencing and Maintenance for 10 years). The condition No. (vi) has been complied by effecting the payment of ₹ 9,16,088/- (Rupees Nine Lakh sixteen Thousand and eighty-eight only) towards Net Present Value of the land. The Condition No. (vii) has been complied by giving an undertaking for payment of Additional NPV.

As per the condition No. (xii) the User Agency has deposited the payment of ₹ 28,52,576/- (Rupees Twenty-eight Lakh fifty-two Thousand and five hundred and seventy-six only) towards Compensatory Afforestation and Net Present Value of the land by RTGS/NEFT as informed in the in-principle approval.

The User Agency has agreed to comply the other conditions of the in-principle approval.


In view of fulfilling the conditions, formal approval is hereby granted to the User Agency - M/s. Gujarat Gas Limited, Gandhinagar, Gujarat to use 0.9756 Ha. of Protected forest land for laying of underground Natural Gas Pipeline parallel and across roads and canalside of village Naroli in the U.T. of Dadra & Nagar Haveli as indicated in the application and the map enclosed along with application, subject to following conditions.

- i The legal status of the forest land shall remain unchanged i.e. shall remain Reserve / Protected / Village / other types of forests / forest as the case may be.

- ii No felling of tree shall be involved in the implementation of the proposal.
- iii The maximum size of the trench shall not be more than 2.00 meter depth and 1.00 meter width.
- iv The pipeline shall be along the road within existing right of way not falling in National parks and Wildlife sanctuaries.
- v Compensatory afforestation shall be taken up by the Forest Department, DNH at the cost of the user agency and the same shall be maintained for 10 years. Only indigenous forest tree species shall be used for such plantations. Trees, if planted on the diverted area, will not be felled without the permission of the Forest department, DNH.
- vi The User agency shall seek permission from the Forest Department, DNH for carrying out any maintenance;
- vii All statutory provisions under various Acts, Rule there under and guidelines applicable to this project shall be strictly adhered to.
- viii The forest land shall not be used for any purpose other than that specified in the proposal.
- ix The User agency shall be responsible for any loss to the flora / fauna in the surroundings and therefore, shall take all possible measures to conserve the same.
