ORDER

In pursuance of the guidelines issued by the Ministry of Environment & Forests, Government of India, referred above In-Principle approval was given for Construction of an Approach Road from Vasda Devipada to Navapada vide letter mentioned at preamble (v) above and on receipt of payment of ₹ 4,59,123/-{Rupees: Four Lakh Fifty Nine Thousand One Hundred Twenty Three only) through RTGS/NEFT (Challan) mode in Corporation Bank, New Delhi by the User Agency the Executive Engineer, PWD Civil Division No. III (Irrt.) (D.P.) towards cost of Net Present Value and Compensatory Afforestation for the diversion of 0.21 hect. of Reserved Forests land approved for diversion as per order of Hon'ble Supreme Court (1A-566 in W.P. (Civil) No. 202/1995) dated 30.10.2002, 01.08.2003, 28/03/2003 and 09.05.2008, the undersigned on behalf of the Administration of Dadra & Nagar Haveli is hereby pleased to permit the User Agency the Executive Engineer, PWD Civil Division No. III (Irri.) (D.P.)to use 0.21 hect of Reserved Forest land for Construction of Approach Road from Vasda Devipada to Navapada in the Union Territory of Dadra & Nagar Haveli as indicated in the application and the map enclosed alongwith application, subject to the following conditions:-

The legal status of the forest land shall remain unchanged i.e. shall remain Reserve / Protected / Village / other types of forests / forest as the case may be.

ii No felling of tree shall be involved in the implementation of the

proposal.

iii Compensatory afforestation shall be taken up by the Forest Department at the cost of the user agency and the same shall be maintained for 10 Years. Only indigenous forest tree species shall be used for such plantations. Trees, if planted on the diverted area, will not be felled without the permission of the State Forest department.

iv Additional amount of the NPV of the diverted forest land if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.

The User agency shall seek permission from local Forest

Department for carrying out any maintenance;

vi All statutory provisions under various Acts, Rule there under and guidelines applicable to this project shall be strictly adhered to.

vii The forest land shall not be used for any purpose other than that

specified in the proposal.

viiiThe User agency shall be responsible for any loss to the flora / fauna in the surroundings and therefore, shall take all possible measures to conserve the same.
