AGENDA ITEMS FOR 12TH MEETING OF THE REGIONAL EMPOWERED COMMITTEE TO BE HELD ON 08TH APRIL, 2016 AT REGIONAL OFFICE, BHOPAL OF MOEF&CC.

I. State: Gujarat

Agenda 1. Diversion of 7.0187 ha Protected Forest land for widening of SH-10 Himatnagar-Idar- Kheroj-Ambaji Road (Section Kheroj to Ambaji Road Km 79/3 to 100/00) under Pravasi Path Yojna in favour of Executive Engineer, R&B Division Palanpur in Banaskantha District of Gujarat (6-GJC021/2011-BHO)

The proposal was received at RO, Bhopal on 15/03/2011 from State Govt. of Gujarat. After examination it was placed in SAG held on 24/05/2011 and was recommended to MoEFCC for consideration and approval.

MoEFCC sought clarification (1) Map shown road network in the area (2) What is the position/ status of the other side of road? (3) Stretches for which approval under FCA have been given and their construction status?. The same was sought from State Govt of Gujarat from the office vide letter dated 22/09/2011. Replies of State Govt of Gujarat at p/ 82-83c.

After examination the replies in this office the file was send to MoEFCC on 21/05/2012. In wish Regional Office, Bhopal re-submitted the proposal for consideration based on the replies submitted by State Govt of Gujarat. MoEFCC sought clarification that 0.525 ha land was diverted vide letter dated 06/01/2012 and why a composite proposal was not sent for approval?

After gap of 2 years (24 months), the State Govt of Gujarat vide letter dated 19/09/2014 submitted clarification that due to separate division and circles the proposal were processed separately and the consolidation of those proposal could not be

envisaged.

The proposal attracts FCA Guideline 4.14 and processed for rejection and accordingly it was approved for rejection. Based on the FCA guideline 4.14, the communication was send to State Govt of Gujarat. State Govt of Gujarat had submitted the reply and requested for approval.

Points to b placed in front of REC for discussion are:-

1) The proposal attracts FCA Guideline 4.14: Rejection/ re-opening.

2) As the proposal is 7.0187 ha may be placed in REC.

3) Consolidation of proposal.

4) As proposal is old, latest Site Inspection report may be needed.

II. State: Madhya Pradesh

Agenda 2. Diversion of 21.393 ha Reserved Forest land for construction of Narmada- Gambhir link project in favour of Executive Engineer, OPS Canal Division in Khargone & Indore Districts of MP (6-MPC 006/2016-BHO)

The proposal was received at Regional Office, Bhopal on 12/02/2016. The proposal was examined in this office and clarification was sought from State Govt. of MP vide letter dt. 26.02.2016 on following points:
