The location of the Katamati Iron Mine falls in Survey of India's Topo-sheet No. 73 F/8 and 73 F/12 with Latitude between N 22^o 05' and N 22^o 10' and longitude E 85^o 25' and E 85^o 30'

The project is situated under Thakurani Reserve Forest under Belaipada Forest Section of Barbil Range of Keonjhar Forest Division and Khesra Forest.

Katamati Iron Mine consists of 403.3238 ha lease area.

The 3rd Renewal of Mining Lease is applied for mining of Iron Ore over 403.3238 ha.. The Iron Ore produced from this mine will be supplied to steel plants of Tata Steel and Tis Group companies.

This Mine is one of the major sources of supply of high grade Iron ore to Jamshedpur works. Within the applied lease area of 403.3238 ha, the forest land constitutes 199.1720 ha (57.5520 Reserve Foest +141.6200 Khesra Forest) +204.1518 ha of Non-Forest land .There is no DLC land. Forest area of 31.1791ha has been broken (R.F 8.2834 ha + K.F 22.8957 ha) prior to 25.10.1980. Presently 196.9719 ha forest land has been sought for diversion for Mining and ancillary activities. (31.1791 ha. broken up forest prior to 25.10.1980 and 165.7928 ha. fresh forest area) and 2.2001 ha. forest area has been used as safety zone.

iii) Cost of the project.

Total cost of expansion of Katamati Iron Mine project is Rs. 45 Crores upto the Production level of 5 million tonnes per annum.

iv) Justification for locating the project in forest area

The Northern boudary of the lease, falls on the inter-state boundary of Orissa and Jharkhand and forms a common boundary with our Noamundi Mining Lease in the State of Jharkhand, over a stretch of Company is operating 3600 mtrs. The Mine to meet the Noamundi requirements of Tata Steel and Tis group companies (including Tata Sponge, Bileipada, Tata Metaliks, Kaharagpur, Tayo, Adityapur etc.) The Company has developed the necessary infrastructure at Noamundi and invested substantially in terms of Plant and Machineries and other infrastructure required for mechanised operation keeping in view of the future development of both Noamundi and Katamati deposits.

Noamundi Iron Mine is in operation for last 75 years and is now encountering "Blue Dust" at lower levels. Major expansion is going on in Tis Group Companies. Hence Katamati mine will have to be developed to mine the total deposit available in both forest and non forest area to meet the iron ore requirement.

To sustain the steel production additional raw material will be required which will be produced and supplied from this mine as well as other mines of the Lesee.

Intensive mineralised zone of Iron ore occurs in the virgin forest area and as such mining has to be carried out in the forest area. However the mineralised zone of both forest & Non-forest area will be worked simultaneously Other ancillary activities linked with mining operation are required to be located close to the mining pit for smooth and economical operation of Mines. It will be located both in forest and non-forest area.

The mining plan has been approved by IBM vide letter No. 314(3)/2000-MCCM (C)/MP-14 dt.6.7.2001. (enclosed) Annexure –VII

The modified mining plan along with mine closure plan have been submitted to IBM vide letter No.GM/PL/194/216/2006 dt. 23.6.2006. (enclosed). **Annexure - VIII**

The total proved mineral reserve is 81.96 million tons.
