Sub:- Compliance of EDS for the Proposal for diversion of 153.938 Ha. Forest land for construction of Kutulusingha Irrigation Project by Superintending Engineer, Angul Investigation Division, Angul.

With reference to the above-cited communication regarding the subject mentioned, the updates on the points raised in your observations are furnished below for your kind information and necessary action.

1. The diversion proposal returned by the PCCF (Nodal) vide his Memo No.16273 dt.22.08.2022 has not been resubmitted by the User Agency to the DFO, Athmallik. In this regard, the User Agency has been requested by the undersigned to bring the FDP from the PCCF (Nodal) and submit the same to this office along with the required compliance.
2. The point-wise compliance in the prescribed format will be prepared and submitted upon receipt of the FDP from the User Agency.
3. Regarding Observation No. 5 of the PCCF (Nodal), the specific views of the DFO, Athmallik, have already been provided in Point No. 8 of the Revised Part-II. Additionally, specific recommendations concerning the project have been included under Point No. 13 of the Revised Part-II.
4. Upon receipt of the FDP from the User Agency, a point-wise compliance report will be appended to the diversion proposal and resubmitted to your office in quadruplicate.
5. The DSS certificate for the degraded forest patch identified for additional Compensatory Afforestation (CA) has already been included in the CA scheme submitted by the DFO, Dhenkanal, and forwarded to your office.

In view of the above observations, the Annexures and undertakings submitted by the User Agency are returned herewith to the User Agency for necessary rectification and resubmission along with the diversion proposal to this office for taking further action.

This is for favour of your kind information and necessary action.
