
Sub:- Compliance of EDS for the Proposal for Diversion of 153.938 ha. forest land for construction of Kutulisingha Irrigation Project by Superintending Engineer, Angul Investigation Division, Angul.

On scrutiny of the compliance submitted vide your memo under reference the following observations are made which may be complied immediately.


1. The diversion proposal returned by PCCF (Nodal) vide his Memo No.16273 dated 22.8.2022 has not been submitted with required compliance as asked vide your memo under reference. You are therefore requested to impress upon the UA to bring the FDP from the O/o. the PCCF (Nodal) and submit the same to the concerned authorities accordingly along with required compliance.
2. The point-wise compliance has not been made vide your memo under reference which need to be furnished.
3. In observation No.5 of PCCF (Nodal), your specific views has not been offered in the compliance report which need to be submitted. Further, in point No.13 of Part-II, you have not given any specific recommendation as the project is located in ESZ and there are frequent movement of elephant in the area as observed by the PCCF (Nodal).
4. The compliance report should be appended with the diversion proposal and submit to this office in quadruplicate.
5. The DSS report of CA land in respect of the DFO, Dhenkanal Division has not been submitted in the prescribed proforma duly signed by the DFO, Dhenkanal Division.

In view of the above discrepancies, the Annexures and undertakings submitted vide your memo under reference is returned herewith for information and necessary action with a request to re-submit the compliance report along with the diversion proposal in quadruplicate to this office at the earliest for further action.




