On scrutiny of the proposal for diversion of 12.202ha. forest land for Single Line Broad Guase Railway Connectivity from Amarda Road to Subarnarekha Port in the State of Odisha submitted vide your memo under reference, the following discrepancies are noticed which may be complied immediately.

- 1- The tree enumeration list and abstract of tree enumeration list in both forest and non-forest land should be authenticated by the OFDC Ltd.
- 2- Certificate on Decision Support System(DSS) for Compensatory Afforestation for the project as per the proforma given by the PCCF, Odisha vide his memo no.21393, dt.13.12.2021 from DFO, Balasore(WL) Division is wanting.
- 3- GPS coordinates of the starting and ending point of the railway connectivity for the project is wanting.
- 4- DGPS map for the CA land identified for the project should be authenticated by the ORSAC.
- 5- In Compensatory Afforestation, seedling cost has been included in the cost norm of the scheme, again the seedling cost has been included in the total financial outlay of the scheme which may be rectified. The CA scheme should be prepared and submitted as per one time cost norm communicated by the PCCF, Odisha vide his memo no.18833, dt.08.11.2021.
- 6- All documents submitted by the User Agency should be ink signed with seal by the User Agency and DFO, Balasore(WL) Division.

You are requested to comply the above points and resubmit the Forest Diversion Proposal for the above project to this office immediately for taking further action at this end. The 4(Four) sets of Proposal submitted vide your memo under reference is returned herewith.
