With reference to the subject cited above and referred letter, it is brought to your kind attention the following information regarding the clarification on proposed road falling under CRZ 1A (Sand dune) area of CRZ notification, 2019.

1. As per the revised CZMP Map, Sheet No: F45P6/SW (Revised), Map No: OD 90 (Copy enclosed as **Annexure-1**), no portion of the proposed road falls in ecologically sensitive area i.e. CRZ-1A ( Sand dune).
2. SPPL has taken up CRZ clearance for the portion of proposed road falls under CRZ zone other than CRZ-1A category, as a part of our fresh EC & CRZ clearance proposal submitted to MoEF&CC vide proposal no. IA/OR/INFRA1/444266/2023 dated 18<sup>th</sup> September-2023.

In this regard your necessary assistance is required for further processing of our Forest Diversion Proposal based on the above clarifications.
