Sub: Proposal for diversion of 6.779 ha of forest land for two lane strengthening / widening / newly build road from Basta to Subarnarekha Port via Dagara beach in the District of Balasore under Balasore (WL) Division by M/s Subarnarekha Port Pvt. Ltd. - GoI observations regarding.

Ref: Letter No.5-ORC582/2023-BHU dtd 13.07.2023 of Dy. Inspector General of Forests (C), GoI, MoEF&CC, Regional Office, Bhubaneswar.

Sir,

In inviting a reference to the above cited memo on the captioned subject, it is to inform that the Government of India, Ministry of Environment, Forest & Climate Change, Regional Office, Bhubaneswar has requested to furnish clarification as to whether construction of proposed road corridor (Dagra village, Baliapal Tahasil, Plot No.2685/Sabik Plot No.779 & Plot No.2685/2710 Sabik Plot No.779) is falling under CRZ-1A(Sand dune) category of CRZ Notification, 2019.

Compliance: The Field Director, STR-cum-RCCF, Baripada Circle has reported that the user agency i.e the Authorised Signatory of Subarnarekha Port Pvt. Ltd. has submitted compliances to the above observations made by the RO, GoI, MoEF & CC as noted below alongwith the revised enlarged CZMP map (Sheet No.F45P6/SW), map No.OD-90 in 1:25000 scale (pertaining to Balasore District duly countersigned by the DFO, Balasore (WL) Division and the Authorised Signatory of the user agency..

1. As per the observation made on the revised CZMP sheet No. F45P6/SW, map No.OD90 duly countersigned by the DFO, Balasore (WL) Division (**Copy enclosed as annexure-II**).
 - (a) A portion of the proposed road passing through Dagara sea beach falls in ecologically sensitive zone area i.e CRZ-1A (Sand dune).
 - (b) A portion of the proposed road is also passing within 200 mt to 500 mt from High tide line- CRZ-III-B zone.
 - (c) Also some portion of proposed road is passing through no development zone area.In view of the above if required the user agency i.e SPPL may have to obtain clearance from the CZMP authority, Odisha as per CRZ notification, 2019.


2. The user agency i.e SPPL has taken up CRZ clearance for the portion of the proposed road falling under CRZ zone other than CRZ-1A category, as a part of their fresh EC and CRZ clearance proposal submitted to the MoEF & CC vide their proposal No.1A/OR/INFRA1/444266/2023 dated.18.09.2023.

In this regard the compliances submitted by the authorised signatory of the user agency dated 27.10.2023 duly countersigned by the DFO, Balasore (WL) Division is enclosed as **Annexure-I**, and the original CZMP (Costal Zone Management Plan) sheet is enclosed as **Annexure-III**.

In view of the above, the compliances to the observations made by GoI, MoEF& CC, Regional Office, Bhubaneswar dated 13.07.2023 is sent herewith for favour of kind information and necessary action.


Sir,


In this regard your necessary assistance is required for further processing of our Forest Diversion Proposal based on the above clarifications.
