

Reference: The State Government letter No.22539/FR.10/2021-2 dated 08.02.2022

Sir,

With reference to the subject and reference cited above, I am directed to request to furnish the following additional information / documents / clarification at the earliest for further consideration of the proposal;

- The State Government reported that out of 1.569 ha, an extent of 1.4537 ha under Nanmangalam RF and an extent of 0.1153 ha area provided to Quaid-E-Milleth Educational Trust . However, details not submitted regarding when the forest area over an extent of 0.1153 ha was handed over to Quaid-E-Milleth Educational Trust i.e. prior to 1980 or diverted under FCA, 1980. Hence, needs clarification that whether 0.1153 ha it is a leased area having status of RF or any dis-reservation has been made?
- The NPV rate needs to be revised as per Ministry's guideline No. 5-3/2011-FC(Vol-I) dated 06.01.2022 and clarification issued vide letter dated 19.01.2022;
- The state forest department shall explore possibility translocation of indigenous tress (in the proposed 112 trees to be felled and removed) either inside the Nanmangalam RF or any nearby places;
- As reported by the DFO, the proposed forest area is prone / susceptible to splash and rill erosion due to poor density of trees. Hence, suitable soil conservation plan may be prepared and submitted to this office;

- e. As per the direction of Hon'ble NGT, the State Government / User Agency may submit the outcome of report / recommendations that have been suggested by the expert agency through which they have conducted the environment impact assessment and biological diversity assessment. } R
