With subject and reference cited above, I am directed to inform that the point wise reply submitted by the Nodal Officer (FCA), Odisha vide letter under reference-2 was examined in this office. The State Govt. has reported 62 nos. of towers in Balliguda and 23 nos. of toweres in Kalahandi (N) Division have been constructed over proposed RF and Revenue forest land without prior approval under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980. However, on further examination of KML files in DSS, it is observed that 66 nos. of towers in Balliguda and 25 nos. of towers in Kalahandi (N) Division have construted over proposed RF and Revenue forest land.

It is therefore requested to recheck the mis-match in number of towers constructed over proposed RF and Revenue forest land and submit detail report to this office at an early date for further necessary action.
