i) District Forest Officer, Chennai Division report on Government of India EDS query Point. a is not specific to the query raised.

ii) As reported for Point. e, of Government of India EDS query, the report of Biodiversity Assessment and Biodiversity Management Plan for Nanmangalam RF prepared by the subject expert Dr. C. Arivazhagan Ecologist has not been uploaded either in EDS reply Sector or in Project proposal (Part I/II).

Further the subject expert's Agency name has not been found a place in the project report. This may be recorded in the report. Hence the report submitted in triplicate copy is returned herewith for further action.

As per the guidelines issued by the Government of India, forest clearance proposal has to be dealt through the web portal. Hence the required details may be uploaded in the web portal early.


