Apropos to the above, this is to inform you that on scrutiny of the diversion proposal, the following discrepancies were noticed which is needs to be complied for further action at this level.

- Check list of the DP doesn't contain any Page No., which needs to be addressed.
- Non-encumbrance & Non-encroachment of Revenue degraded Forest land identified for CA land duly signed by the Tahasildar, Nilgiri is part of the Proposal.
- Allotment order of the identified CA land (degraded forest land) issued by the competent authority i.e. Collector, Balasore shall be attached to the diversion proposal to enable this office for taking further course of action towards transfer of ownership in favour of Forest, Environment & Climate Change Department, Govt. of Odisha and declaration of the same as Protected Forest under relevant Act & Rules.
- Enumeration of tree growth over Forest & Non-Forest kissam of land in the prescribed proforma as requested vide this office Memo No. 6231 dated 20.07.2022 shall be enclosed with the DP.

You are requested to comply the above deficiencies narrated and resubmit the diversion proposal for further action at this level.
