Sub: Guidelines for diversion of forest land for non-forest purposes under the Forest

Sir.

Detailed guidelines for submission of proposals for diversion of forest land for non-forestry purposes under the Forest (Conservation) Act, 1980 were finalised and circulated to all the State Government/Union Territories on 25.10.1992. A constant review of these guidelines has been done from time to time. After a recent review the Ministry has observed that in certain proposals of public importance involving laying underground telephone lines/optical fiber cables and drinking water supply pipelines the land requirement is small, the land use is temporary & usually one time affair, is in a form of strip with minimum damage, which is restored after use and are normally laid along the roads.

In view of the above, the Central Government hereby conveys its general approval under Section-2 of the Forest (Conservation) Act., 1980 for diversion of forest land for underground laying of optical liber cables, underground laying of telephone lines & underground laying of drinking water supply pipelines which involve no tree felling, are outside National Parks or Wildlife sanctuary, are laid along the oads and within the existing right of way and the maximum size of the trench is 2.00 metre depth & 1.00 netre width. Any deviation from the above category/conditions will require separate submission of proposal/permission under Forest (Conservation) Act, 1980.

This approval will be subject to the following conditions:

The user agency will seek permission from the State Forest Deptt. under local Acts/Rules, etc.

The user agency agrees to make good the land after use/maintenance.

The user agency agrees to make good any loss to forest/environment.

The user agency seeks permission from local Forest Deptt. for carrying out any maintenance.

The State Government/Union Territories will submit a quarterly progress report on the extent of ne forest land diverted for each purpose to the Ministry as well as the concerned Regional Offices. This pproval under the Forest (Conservation) Act, 1980 is being conveyed initially for a period of two years ibject to review thereafter.

Mr. Detailed guidelines for submission of proposals for diversion of forest land for non-forestry purposes under the Forest (Conservation) Act, 1980 were finalised and circulated to all the State Government/Union Territories on 25.10.1992. A constant review of these guidelines has been done from time to time.

After a recent review the Ministry vide letter of even number dated 16.10.2000 had conveyed its general approval under Section-2 of the Forest (Conservation) Act, 1980 for diversion of forest land for underground laying of optical fiber cables, underground laying of telephone lines & underground laying of drinking water supply pipelines which involve no tree felling, are outside National Parks or Wildlife Sanctuary, are laid along the roads and within the existing right of way and the maximum size of the trench is 2.00 metre depth & 1.00 metre width. This permission has been granted subject to certain parameters/conditions.

In continuation of the above mentioned letter, it is clarified that this approval would also be applicable in case of laying of underground electricity cables, which shall be subject to all the stated parameters and conditions stipulated in the letter dated 16.10.2000. The State Government/user agency should ensure that the channels dug for underground laying are duly filled up and compacted so that these do not become source of constant soil erosion.

Now, in continuation of the above mentioned letters, the period of general ocimission is extended for a period of one year i.e. with effect from 16.10.2002 to 15.10.2003 ubject to all the stated parameters and conditions stipulated in the letters dated 16.10.2000 and

Detailed guidelines for submission of proposals for diversion of forest land for non-forestry purposes under the Forest (Conservation) Act, 1980 were finalised and circulated to all the State Government/Union Territories on 25.10.1992. A constant review of these guidelines has been done from time to time.

After a review, the Ministry of Environment & Forests, Government of India vide letters of even number dated 16.10.2000, 31.10.2001 and 23.12.2002, had conveyed its general approval under Section-2 of the Forest (Conservation) Act, 1980 from time to time, for diversion of forest land for underground laying of optical fiber cables, underground electric cables, underground laying of telephone lines and underground laying of drinking water supply pipelines subject to certain parameters/conditions. Last general approval will expire on 15.10.2003. Considering requirement of infrastructure development in the country and for their expeditious implementation, the Ministry of Environment & Forests, Government of India further extends the period of general permission for a period of two years i.e. from 16.10.2003 to 15.10.2005, subject to all the parameters and conditions stipulated in the letters dated 16.10.2000, 31.10.2001 & 23.12.2002.
