Sir,

In inviting a reference to the above cited memo on the captioned subject, this is to inform you that, the Additional Principal Chief Conservator of Forests, Forest Diversion & Nodal Officer, FC Act was approved the financial outlay of compensatory afforestation scheme over an area of 51.520 ha. of Degraded Forest Land identified in Gudigaon Village under Kolabira Forest Range in Jharsuguda Forest Division against above project involving an amount of Rs.47,85,754/- at the wage rate of Rs.200/-per MD & the said amount has already been deposited by you in the CAMPA account.

Further, the wage rate has been revised from 200/- to 452/- per MD. Hence, the Additional Principal Chief Conservator of Forests, Forest Diversion & Nodal Officer, FC Act has approved the revised financial outlay of compensatory afforestation scheme vide his memo No. 25727/9F(ET)-04/2016 dt.20.12.2024 involving an amount of Rs.2,59,15,800/- at the wage rate of Rs.452.00 per MD.

In this regard, you are requested to deposit of an amount of Rs.2,11,30,046.00 (Rs.2,59,15,800.00-47,85,754.00) (Rupees Two Crore Eleven Lakh Thirty Thousand Forty Six) only towards the differential cost of compensatory afforestation scheme in the CAMPA account through Parivesh Portal. The evidence of depositing the amount may be forwarded to the undersigned for further needful action at this end.

Furthermore, as per instruction made in the above letter by the Chief Conservator of Forests(Nodal), you are requested to furnish the cogent reasons for delay in submission of Stage-I compliance in complete shape as more than 5 years have been elapsed.



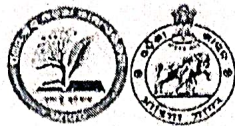
