With reference to the letter cited above, I am writing to bring to your attention the non-submission of stipulated conditions vide item No.(i) to (v), as mandated by the Ministry of Environment, Forest and Climate Change (MoEF&CC) in relation to Basundhara Washery (10 MTY) by Mahanadi Coal fields Limited (MCL).

The Hon'ble Supreme Court has directed the MoEF & CC for upward revision of Net Present Value (NPV) rate in compliance of order dated 28.03.2008 in writ petition (Civil) No.202 of 1996 in the matter of T.N. Godavarman Thirumalpad Vrs Union of India & Ministry Guideline dated 05.02.2009, you are liable to pay differential cost of Net Present Value (NPV) against the diverted forest land over 29.41ha.

However, the differential amount of Net Present Value is furnished below:-

Additionally, you are requested to deposit the differential amount of NPV of Rs.69,30,884/- (Earlier NPV for 20.89Ha - Rs.2,00,08,024/- (-)Rs.1,30,77,140/- = Rs.69,30,884/- balance to be paid).

Therefore, as per direction of DIG of Forests, MoEF & CC, GoI, in the FRCM meeting held on 25.11.2024, you are requested to and attend this office on dated 10.12.2024 at 11.00 AM along with above compliance to discuss the above compliance by the undersigned, for taking further action and onward transmission to higher quarters.
