It is submitted that the Government of India vide reference 6th cited has conveyed Central Government **in-principle** (Stage-I) approval under Section 2 of Forest (Conservation) Act, 1980, for diversion of forest land to an extent of 4.115 ha (Nizamabad 2.168 ha + Banswada 1.947 ha) under Nizamabad & Kamareddy Districts, for laying of Pipeline and Construction of structures in Segment-12/3 (Banswada) under Telangana Drinking Water Supply Project, in favour of Superintending Engineer, TDWSP (RWS&S) Circle, Nirmal. In the reference 6th cited, the said orders has been communicated to all the concerned officers with instructions to submit condition-wise compliance report in the matter, for seeking Stage-II (Final) approval.

Accordingly, the District Forest Officers, Nizamabad and Kamareddy has obtained compliance of conditions from the User Agency/Forest Divisional Officers, Nizamabad and Banswada; and submitted the condition-wise compliance report together with its enclosures through Chief Conservator of Forests, Nizamabad, which is received in this office through reference 8th cited. A copy of the reference 8th cited together with its enclosures **in triplicate** are enclosed herewith.

The condition-wise compliance report is reproduced with remarks as follows:-

The User agency has deposited an amount of Rs.66,66,992/- (36,94,192+29,72,800) into the account of Telangana State CAMPA, New Delhi, Lodhi Complex, with UTR No's.IDIBH18071396947 & IDIBH18071397068, dt.12.03.2019 respectively which includes an amount of Rs.37,07,292/- towards CA scheme against the project proposal No.FP/TG/WATER/ 18278/2016 and same is reflected online in the Ministry's portal.

6.	Non-Forest land identified for raising compensatory afforestation shall be transferred and mutated in favour of the State Forest Department before issue of the Stage-II clearance. Out of 71.082 ha, the non-forest land to an extent of 4.115 ha will be apportioned for this segment, as per the approved CA scheme.

Non-Forest land which is transferred and mutated in favour of the state Forest Department for the purpose of Compensatory Afforestation, shall be declared as Reserved Forest under section-4 or Protected Forest under Section 29 of the Indian Forest act, 1927 or under the relevant section(s) of the local forest act. The Nodal Officer must report compliance with in a period of 6 months from the date of grant of final approval and send a copy of the original notification declaring the non forest land under section 4 or section 29 of the Indian Forest act, 1927 or under the relevant section of the local forest act as the case may be, to this office for information and record.	The non-forest CA land transferred & mutated in favour of State Forest Department will be declared as PF/ RF under Telangana Forest Act, 1967 within a period of six months upon receipt of Stage-II approval.

Precautions have to be taken to avoid concerned of livestock at the water point.

The Progress of the Compensatory afforestation as mentioned by the DFO, Armoor Division SI.No.12(V)(a) (b) of part-II i.e., 22 ha of forest land shall be monitored by the Circle Head and a copy of such monitoring report shall be forwarded to the Regional Office to upload the same in the web portal.	The progress of the Compensatory Afforestation will be monitored by the concerned field officers and copy of the monitoring report will be forwarded to the Regional Office, MoEF & CC, Chennai through Nodal Officer for FCA, from time to time besides uploading of the same in web portal.
23.	User agency and the State Government shall ensure compliance to provision of the all Acts, Rule's Regulations and Guidelines, for the time being in force, as applicable to the project.	The User Agency has agreed to comply with the condition and submitted an undertaking, which is enclosed herewith
24.	Any other conditions that the Central Government or Addl. PCCF (Central) of Regional Office, Chennai may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the user agency. 25.	In the event of failure to comply with any of the above conditions the user agency is liable for penal action as decided by the Additional PCCF (Central), Regional Office, Chennai.	The User Agency has agreed to comply with the condition and submitted an undertaking, which is enclosed herewith.

The Government are requested to forward the condition-wise compliance report to the Ministry of Environment, Forests & Climate Change, Regional Office (South Eastern Zone), Chennai and obtain final (Stage-II) approval under Section 2 of Forest (Conservation) Act, 1980 and communicate the orders in the matter, at an early date.
