**Sub:** Diversion of 2.4314 hectare of forest land in Deogiri Swmimalai Forest Block in Sandur Taluk, Ballari District for establishing Downhill Conveyor Pipe System (DCS) from Kammathuru Iron Ore Mine (ML No. 2678 old No.2580/1179) to PMBR (BMM) siding in favour of M/s Sandur Manganese and Iron Ores Limited (SMIORE), Lakshampur, Sandur Taluk, Ballari District (**Online Proposal No. FP/KA/MIN/31165/2018**).

With reference to the above subject, Final (Stage-II) approval accorded by Ministry of Environment, Forest & Climate Change (Forest Conservation Division) and the Government of Karnataka for Diversion of 2.4314 hectare of forest land in Deogiri Swmimalai Forest Block in Sandur Taluk, Ballari District for establishing Downhill Conveyor Pipe System (DCS) from Kammathuru Iron Ore Mine (ML No. 2678 old No.2580/1179) to PMBR (BMM) siding in favour of M/s Sandur Manganese and Iron Ores Limited (SMIORE), Lakshampur, Sandur Taluk, Ballari District imposing certain conditions vide letter under Ref (1) & (2).

Further, the Principal Chief Conservator of Forests (Forest Conservation) & Nodal officer, Bangalore has directed the undersigned to execute an Agreement with the User Agency duly incorporating all the conditions imposed by the Government of India, the Government of Karnataka and the standard conditions applicable to FC leases from time to time and further subject to payment of any recoverable balance in compliance of the conditions of Stage-I & Stage -II (final) approvals. vide letter under Ref (3).

Further, it is observed that, the Principal Chief Conservator of Forests (Head of the Forest Force), Bangalore has revised Compensatory Afforestation(CA) charges vide letter under Ref(4).


