Pavan Kumar Reddy subject to fulfillment of certain conditions laid down therein.

 - Once it is verified by the Nodal Officer, the User Agency can generate e-challan from the portal.

Further, the user agency should comply the following in accordance with the Government of India instructions issued vide F.No.7-23/2012-FC, dt.24.07.2013 communicated in PCCF Rc.no.45921/2001-F4, dt.23.08.2013 and publish the orders at the cost of the project proponent.

1. Publish the entire forest clearances granted in verbatim along with the conditions and safe-guards imposed by the Central Government in two widely circulated daily newspapers, one in vernacular language and another in English language, so as to make people aware of the permission granted to the project proponent for use of forest land for non-forest purposes.
2. The copies of the Forest clearance should also be submitted to the Heads of local bodies, Panchayats and Municipal Bodies by the project proponents in addition to the relevant offices of the Government who in turn have to display the same for 30 days.

Hence, the User Agency is requested to submit the compliance as per the conditions stipulated in the reference 1st, 2nd cited with condition wise relevant proofs / undertakings in (6) sets, as addressed vide ref.6th cited, for onward submission to the Principal Chief Conservator of Forests (HoFF) AP, Guntur through the Chief Conservator of Forests,Guntur Circle, Guntur for further action. **The condition-wise compliance shall be submitted in PARIVESH portal too.**

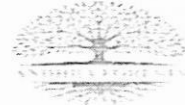

The District Forest Officer, Palnadu is informed that in the reference 1st cited the Government of India MoEF & CC.R.O, Chennai has accorded approval for the diversion of 4.84ha. of forest land in compartment no.102 of Janapadu RF, Guntur Range of Guntur Division for quarry lease for limestone (minor) in favour of Sri G.Pavan Kumar Reddy in principle (Stage-I) duly imposing certain conditions which are to be complied by the user agency.

The District Forest Officer further informed that as per the conditions imposed by GOI vide condition No (iii), (xv) and (xvi) funds have to be collected towards Compensatory afforestation from the user agency. Accordingly, the DFO, Guntur, Palnadu, and Prakasam have submitted the CA Schemes and requested approve the same for the raising of demand notice to the User Agency.
