This Office is Given an "In Principle" Approval for diversion of **0.522** ha. of Protected forest Land for Laying Optical Fiber Cable along the Routes. Vide this Office latter date.23-09-2020 refered above at (4).

The Railtel Corporation of India Ltd. on behalf of Bharat Broadband Networtk Ltd. (NOFN) Project registration Fees & Processing fees is exemption vide Government of Gujarat, Forest & Environment Department Gandhinagar's Resolution No. FCA-1016-290-F Dt-25.05.2016 so Registration Fees & processing Fees is not applicable for this proposals under above references 5.

The under signed is pleased to convey the **Formal Approval** of the Government under Section 2 of the Forest (Conservation) Act, 1980, subject to the following condition:-

- 1. This permission is granted only for use of the forest land for the purpose specified in the proposal. The legal status of the forest land shall remain unchanged.
- 2. The forest land shall not be used for any purpose other than that specified in the FCA proposal.
- 3. The user agency will have to obtain permission from the under signed for carrying out any maintenance work in future.
- 4. The user agency will have to make good the forest land after use/maintenance work **No tree** shall be cut.
- 5. The user agency will be liable to make good any loss to Forest/Environment caused due to the use of the said land by the user agency.

- 6. The user agency will seek permission from the Road & Building Department/Science & Technology Dept. Sachivalaya, Gandhinagar, if required so. 7.
- The Optical Fiber Cable line will be laid underground in a trench of depth of 1.65 meters and width of 0.45, in between rows of road side plantation. 8.
- Any other condition, which the Nodal officer (FCA)/the state Government may stipulate from
