Further, the User Agency is requested comply with the following in accordance with the MoEF& CC, GoI instructions issued vide F.No.7-23-2012-FC,dtd.24.07.2013 communicated vide PCCF., Hyderabad Rc.No.45921/2001/F4, Dt: 23.08.2013.

 Publish the entire forest clearances granted to the project proponent for the use of forest land for the non-forest purpose in verbatim along with the conditions and safeguards imposed by the Central Government in two widely circulated daily newspaper i.e., one is vernacular language and the other in English. 2. The copies of the clearance should also be submitted to the heads of local bodies, Panchayats and Municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days from the date of receipt of this reference.

The transfer of forest land to User agency **shall not be affected** prior to the issue of final approval (or) working permission whichever is earlier.
