The Additional Principal Chief Conservator of Forests, Maharashtra State, Nagpur has submitted proposal for diversion of 12.7435 ha. Forest land under section-2 of the Forest (Conservation) Act, 1980 for laying of 220 KV LJLO M/C Transmission Line on 220 KV Padghe-Wada Transmission Line at LOC No. 97 for 220 KV Abhitghar substation passing through Palghar District.

2. The said proposed line is primarily to provide power to the present and future load demand of looking at present condition there is heavy load shedding of power. In Abhitghar belt is very essential to construct and operate 220 KV LILO Transmission line on 220 KV Padghe-Wada line at LOC No.97 for 220 KV Abhitghar Substation for zero shedding to be implemented wef effect that time there is removal problem faced by MSEDCL in load distribution in that area development of agriculture and tribal area.

3. The Concerned Deputy Conservator of Forests, Jawhar has certified that:-

- 3.1) No alternate alignment is possible and the forest land required is barest minimum.
- 3.2) The area belongs to Eco-value class-I having density is above 0.7 (Dense Forest).
- 3.3) There are 6311 trees of various species and trees is involved in implementation of the project. Girth wise break up of trees is as under:-

- 3.4) The area involved in the project does not form part of any existing National Park, Wildlife Sanctuary, Nature Reserve etc.
- 3.5) Proposed project is not likely to affect any monumental site of cultural, historical, religious, archeological or recreational importance.
- 3.6) There is no violation of Forest (Conservation) Act, 1980.
- 3.7) Proposed project is 1.608 Kms of the boundary of the Tansa Wildlife Sanctuary. Also the proposed alignment does not fall within Eco-Sensitive Zone. PCCF (WL) has suggested that a comprehensive site specific mitigation plan to be prepared in consultation with the filed officials.
- 3.8) Proposed Compensatory Afforestation over 26.00 ha. degraded forest land (i) 10.00 ha. in Compt. No.18, Survey No.11, at Village Tandala, Taluka Mahoor, Dist. Nanded (ii) 16.00 ha. in Compt. No.588, Survey No.64, at Village Rudrapur, Tal. Biroli, Dist. Nanded it is contiguous, suitable for afforestation and management purpose and it is free from encroachment and an encumbrances.
- 3.9) The non-forest area covered under the project is not under the provision of Maharashtra Private Forest (Acquisition) Act 1975 by virtue of application of

Section 35 of Indian Forest Act 1927 and are not recognized as deemed reserved forest as well as not included in the area identified as "forest" as per dictionary meaning of forest as intimated to the expert committee appointed under interim judgment of the Hon'ble Supreme Court dated 12/12/1996.

- 3.10) The proposed alignment is best suitable from forestry point of view.
- 4. The User Agency has submitted undertakings:-
 - 4.1 to defray the cost of Net Present Value.
 - 4.2 to defray the cost of Compensatory Afforestation.
 - 4.3 to submit compliance under FRA-2006.
- 5. The Principal Chief Conservator of Forests (HoFF). Maharashtra State, Nagpur has recommended the proposal subject to the conditions, given in his specific recommendations, under Section-2 (ii) of the Forest (Conservation) Act. 1980. His specific recommendations are enclosed in the proposal.
- 6. The circumstances explained in the aforesaid paragraphs and enclosures, the State Government recommends that the said forest land may be allowed to be diverted subject the conditions proposed by the Principal Chief Conservator of Forests (HoFF), Maharashtra State, Nagpur as well as following additional conditions:-
 - (i) Principal Chief Conservator of Forests (Wildlife) shall submit comments regarding specific Mitigation measures required for the project, before Stage-I approval.
 - (ii) User Agency shall compensate the Private landholders of the proposed Land, as per prevalent Acts and Rules in this regard.
 - (iii) The User Agency shall submit records of rights of proposed forest land at village Goleghar Gut No. 19, 6, 5, 18, 16, 20, 21 and 22 before Stage-I approval.

The matter may kindly be placed before the Government of India for its approval under Section-2 (ii) of the Forest (Conservation) Act, 1980, be obtained and communicated to this Government.
