विषय: हिन्दुस्तान पेट्रोलियम कॉर्पोरेशन लि० कानपुर द्वारा जनपद-फतेहपुर के अंतर्गत फतेहपुर-जोनिहा मार्ग(अन्य जिला मार्ग) के किमी० स्टोन सं०-14.200 के मध्य बांयी पटरी पर गाटा सं०-1502, ग्राम-असवार तारापुर, परगना-फतेहपुर, तहसील-फतेहपुर, जिला-फतेहपुर में रिटेल आउटलेट पेट्रोल/डीजल पम्प के सम्पर्क मार्ग के निर्माण में प्रभावित 0.08047 हे० संरक्षित वन भूमि के बिना वृक्ष पातन के गैर वानिकी प्रयोग की अनुमति के संबंध में।

महोदय,

उपरोक्त विशेष सचिव(वन), उत्तर प्रदेश का पत्रांक-पी-03/81-2-2021-800(18)/2021, लखनऊ, दिनांक-02.03.2021 का आशय ग्रहण करने का कष्ट करें। जिसके द्वारा विषयांकित प्रस्ताव पर वन(संरक्षण) अधिनियम, 1980 की धारा (2) के अन्तर्गत भारत सरकार की स्वीकृति माँगी थी।

प्रकरण में विचारोपरान्त मुझे आपको यह सूचित करना है कि केन्द्र सरकार हिन्दुस्तान पेट्रोलियम कॉर्पोरेशन लि० कानपुर द्वारा जनपद-फतेहपुर के अंतर्गत फतेहपुर-जोनिहा मार्ग(अन्य जिला मार्ग) के किमी० स्टोन सं०-14.200 के मध्य बांयी पटरी पर गाटा सं०-1502, ग्राम-असवार तारापुर, परगना-फतेहपुर, तहसील-फतेहपुर, जिला-फतेहपुर में रिटेल आउटलेट पेट्रोल/डीजल पम्प के सम्पर्क मार्ग के निर्माण में प्रभावित 0.08047 हे० संरक्षित वन भूमि के बिना वृक्ष पातन की सैद्धान्तिक स्वीकृति निम्नलिखित शर्तों पर प्रदान करती है:-

1. Legal status of the forest land shall remain unchanged.
2. Compensatory afforestation shall be taken up by the Forest Department for plantation of 100 trees in Budvan Forest Block, Khaga Range, District Fatehpur at the cost of the User Agency. As far as practicable a mixture of local indigenous species will be planted and monoculture of a species has to be avoided.
3. The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
4. The State Government shall charge the Net Present Value (NPV) for the 0.08047 ha. forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009 in this regard.

5. Penal NPV to be imposed & collected as per the FCA guidelines dated 29-01-2018 and deposited to CAMPA fund.

6. Penal CA shall be taken up by Forest Department for plantation of 100 trees at the cost of User Agency.

7. Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.

8. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.

9. Greenery will be maintained by user agency around Periphery of petrol pump.

10. User agency shall use the land between entry and exit for plantation and conservation of trees, the same shall be demarcated by 2 feet wall.

11. Plantation shall also be done along the inside boundary of Fuel Station.

12. No violation of FCA certificate from concerned DFO shall be provided.

13. Certificate of DFO certifying that the proposed RO is not in close proximity of any existing RO in accordance with MORTH guidelines dated 24-07-2013 has to be provided.

14. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.

15. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.

16. The KML file of the area to be diverted, the CA areas, the proposed SMC work, the proposed Catchment Area Treatment area and the WLMP area shall be uploaded on the e-Green watch portal with all requisite details, before issuing working permission towards linear projects or submitting compliance report for seeking Stage-II approval, as the case may be.

17. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.

18. All the funds received from the user agency under the project shall be transferred/ deposited to CAMPA fund only through e-portal (<https://parivesh.nic.in/>).

19. The compliance report shall be uploaded on e-portal (<https://parivesh.nic.in/>).

After receipt of compliance report on fulfillment of all of the above conditions from the State Government, proposal will be considered for final approval under Section-2 of the Forest (Conservation) Act, 1980, by this office.

The order for transfer of forest land to user agency shall not be issued by the State Government till final approval order for diversion of forest land is issued by Government of India.
