- Sub: Forests Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 Diversion of 0.36 ha of forest land in Avanam Reserved Forest for upgradation of Kappukkadu earthern road to Thar road and street light facilities in Periyanayagipuram Panchayat to join the sand road of the small village North-Thulukkaviduthi, Avanam, Periyanayagipuram, Thanjavur District in favour of the Block Development Officer, Peravurani @ Avanam, Thanjavur District Forwarding of In-principle approval Requested Regarding.

I am directed to enclose a copy of the reference cited and to state that, the Principal Chief Conservator of Forests (Head of Forest Force) in his letter first cited has stated that, the User Agency, the Block Development Officer, Peravurani @ Avanam, Thanjavur District has furnished online application for diversion of 0.36 ha of forest land for Upgradation of Kappukkadu Earthen road in Periyanayagipuram Panchayat to join the sand road of the small village North-Thulukkaviduthi, Avanam, Perianayagipuram (Thar Road and street light facilities) in Thanjavur District in favour of the Block Development Officer, Peravurani @ Avanam, Thanjavur District under Section 2 (1) of Van (Sanrakshan Evam Samvardhan Adhiniyam), 1980 under the Proposal No.FP/TN/Road/147896/2021.

2. In the Part-II of Form-A, the District Forest Officer, Thanjavur Division has furnished the following particulars:-

i) Forest area diversion of 0.36 ha of forest land in Avanam Reserved Forest of Thanjavur Division has been proposed for diversion by the user agency. Eco-class of forest area reported as Eco-Class IV with density of forest area reported as 0.3.

- ii) No trees are available in the proposal project area.
- iii) No work in violation of the Act or Guidelines under the Act has been carried out.
- iv) Significance of the forest land proposed for diversion reported from Wildlife point of view reported by the District Forest Officer is as follows:
  - a. No wildlife present in and around the proposed forest land.
  - b. The forest area proposed for diversion is not located within the Eco-sensitive zone of protected areas.
  - c. There is no rare/ endangered / unique species of flora and fauna found in the area.
- v) There is no protected archaeological/ heritage site / defense establishment or any other important monument is located in the area.
- vi) Requirement of forest land as proposed by the User Agency is unavoidable and bare minimum for the project, the District Forest Officer reported as Yes.
- vii) For the diversion of 0.36 ha of forest land, compensatory afforestation has been proposed for planting of 100 number of seedlings in 0.529 ha of degraded forest land of Avanam Reserved Forest including ten years maintenance period at project cost of Rs.1,75,975/-. Kml file of the selected degraded forest land, location marked in the Survey of India topo sheet, Geo-referenced map, site suitability certificate and Compensatory Afforestation scheme details have been uploaded.
- viii)The District Forest Officer has uploaded the site inspection report of the proposed forest diversion area.
  - a. The District Forest Officer, Thanjavur has inspected the proposed project area in Avanam Reserved Forest Thanjavur District on 14.12.2022.
  - b. The term used by the User Agency for upgradation of road is not existing road, no Right of Way permitted or no earlier approval accorded under Forest Conservation Act, 1980. The pathway used by Forest Department for perambulation since the notification of Reserved Forest is now proposed for black topping.
  - c. The area proposed for diversion by the User Agency is very minimum and there is no alternative land for the proposed project except the forest land.
  - d. The User Agency has not started any work proposed inside Avanam Reserved Forest. Therefore, the question of violation of provision in Forest Conservation Act, 1980 for this proposal does not arise.
  - e. The User Agency shall pay the net present value imposed (Rs.2,41,250/-) as per the revised Forest Conservation Act, 1980 guidelines.
  - f. The District Forest Officer has also stated that the proposed site for Formation of Road (600m x 6.00m = 3600sqmt) 0.36 ha in R.S.No.130 to 147 at Avanam village inside Avanam Reserved Forest of Pattukottai Range in Thanjavur Division. The project is designed to connect Pulichankadu village with Thulukkaviduthi North village in Thanjavur district. Thulukaviduthi North village people will be benefitted as this is the shortest route to reach school, hospital and sell their agricultural goods. Since it is a

genuine requirement, it can be permitted within the guidelines of Forest Conservation Act, 1980.

- g. The Chief Conservator of Forests, Trichy has stated that the proposed area for diversion is 0.36 ha in Avanam Reserved Forest in Thanjavur Forest Division was inspected by him on 18.01.2023 along with the District Forest Officer, Thanjavur. This project for the diversion of 0.36 ha is for the Formation of Road in connecting Pulichankadu village with Thulukkaviduthi North village. No Right of way permitted or no earlier approval accorded under Forest Conservation Act, 1980. The pathway used by Forest Department of perambulation since the notification of Reserved Forest is now proposed for black topping. This project will be very useful for reach school, marketing and hospital purposes. The proposed area is bare minimum and there is no alternative land for the proposed project. No rare / endangered / unique species of flora and fauna in the Avanam Reserved Forest. There is no alternate land available.
- h. Taking into consideration of the facts stated above. the District Forest Officer, Thanjavur Forest Division and the Chief Conservator of Forests, Trichy in the Part -II of Form - A has recommended the proposal for Diversion of 0.36 ha of forest land in Avanam Reserved Forest of Thanjavur Forest Division for Upgradation of Kappukkadu Earthen road in Periyanayagipuram Panchayat to join the sand road of the small village North-Thulukkaviduthi, Avanam, Perianayagipuram (Thar Road and street light facilities) in Thanjavur District in favour of the Block Development Officer, Peravurani @ Avanam, Thanjavur District under Section 2 (1) of Van (Sanrakshan Evam Samvardhan Adhiniyam), 1980.

3. The Principal Chief Conservator of Forests (HoFF) has also stated that, the proposal is sent through parivesh portal duly recommended by the Principal Chief Conservator of Forests (Forest Conservation Act) / Nodal Officer of Forest (Conservation) Act, of the State of Tamil Nadu in Part-III of Form-A.

4. Based on the recommendations made by the District Forest Officer, Thanjavur Division and the Principal Chief Conservator of Forests (Forest (Conservation) Act) of Tamil Nadu, the Principal Chief Conservator of Forests (HoD) has forwarded the proposal for diversion of 0.36 ha of forest land in Avanam Reserved Forest of Thanjavur Forest Division for upgradation of Kappukkadu Earthen road in Periyanayagipuram Panchayat to join the sand road of the small village North-Thulukkaviduthi, Avanam, Perianayagipuram (Thar Road and street light facilities) in Thanjavur District in favour of the Block Development Officer, Peravurani @ Avanam, Thanjavur District under Section 2 (1) of Van (Sanrakshan Evam Samvardhan Adhiniyam), 1980 for a period of 20 years, without specifying any conditions and requested the Government to consider the same and to obtain approval for the same from the Government of India.

5. The Government have examined and accept the proposal (FP/TN/Road/147896/2021) of the Principal Chief Conservator of Forests (Head of Forest Force) for diversion of 0.36 ha of forest land in Avanam Reserved Forest of Thanjavur Forest Division for Upgradation of Kappukkadu Earthen road in Periyanayagipuram Panchayat to join the sand road of the small village North-

Thulukkaviduthi, Avanam, Perianayagipuram (Thar Road and street light facilities) in Thanjavur District in favour of the Block Development Officer, Peravurani @ Avanam, Thanjavur District under Section 2 (1) of Van (Sanrakshan Evam Samvardhan Adhiniyam), 1980 for a period of 20 years, and decided to recommend and forward the same to Government of India in Parivesh 2.0 portal for obtaining In-principle approval of the Competent Authority under section 2 (1) of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980, subject to the following conditions:-

- i) The legal status of the diverted forest land shall remain unchanged.
- ii) Demarcation of the proposed forest land shall be carried out by the User Agency by erecting 4 feet high cement concrete pillars duly numbered at the 20 meter interval at the cost of user agency.
- iii) The user agency has to pay the cost towards compensatory afforestation scheme for the selected degraded forest area in Avanam Reserved Forest as per the Compensatory afforestation scheme including maintenance for a period of 10 years.
- iv) The user agency has to pay the Net Present Value of proposed forest diversion area which will be fixed as per the guidelines of Hon'ble Supreme Court of India/ Government of India,
- v) The user agency has to bear the additional amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India as fixed by the Forest Department in future. The user agency has to furnish undertaking to this effect.
- vi) Amount for Compensatory afforestation scheme, Net Present Value of forest area under the project shall be transferred/ deposited to CAMPA fund only through e-portal (<u>https://parivesh.nic.in/</u>)
- vii) The layout plan of the proposal shall not be changed without the prior approval of Central Government.
- viii) No labour camp shall be established on the forest land.
- ix) No breaking up of forest land or felling of tree shall be allowed;
- x) While black topping, adequate precautions should be undertaken by the User Agency to avoid any damage to flora and fauna. Fire for melting of coal tar and mixing shall be lit at a safe distance from the trees/vegetation and avoiding dry/hot seasons. Fuelwood, if required, shall be purchased in advance from the Depot of Forest Development Corporations;
- xi) No crushing/breaking of stones shall be allowed inside forest areas. Readymade materials shall be used for up-gradation of such roads.
- xii) Bitumen cold mix for black topping should be prepared outside the forest or at a site approved by the Divisional Forest Officer.
- xiii) The user agency shall try to maintain the road surface as rough as possible to act as regular speed governor, even if it means going below the standards prescribed for the particular class of roads, the intention being only to make it an all-weather road.
- xiv) The user agency shall provide side drains for proper drainage.
- xv) The forest land proposed for diversion shall under no circumstances be transferred or sublet to any other agency, Department or person without prior approval of the competent authority.
- xvi) The User Agency has to pay the cost towards annual lease rent for the forest area diversion period as fixed by the Forest Department at the time of sanction along with any escalation for the forest land to be diverted to the above project in future for the entire project period.
- xvii) The total forest area utilized for the project shall not exceed 0.36 ha area in Avanam Reserved Forest and the forest area diverted shall not

be used for any other purpose other than those shown in the diversion proposal.

- xviii) The user agency shall ensure compliance to provisions of the all Acts, Rules, Regulations and Guidelines for the time being in force, as applicable to the Project.
- xix) In the event of failure to comply with any of the above conditions, the user agency is liable for penal action as per the provisions of the Ministry of Environment, Forests and Climate Change guidelines.
- xx) Period of lease is twenty (20) years. The User Agency has to apply renewal proposal before one year of expiry of lease with the State Forest Department.

6. I am, therefore, directed to request you to kindly obtain the concurrence of the Competent Authority and communicate the same to this Government, early.

10) The area proposed for diversion of 0.36ha of forest land for Upgradation of Kappukkadu Earthen road in Periyanayagipuram Panchayat to join the sand road of the small village North-Thulukkaviduthi, Avanam, Perianayagipuram, in Thanjavur District (Thar Road and street light facilities) in Thanjavur Förest Division is recommended and forwarded to the Government of Tamilnadu for considering the proposal under the General Category as per chapter 4.3 of Handbook on FCA guidelines wherein the State Government has been empowered to divert forest areas upto one Ha for critical public utility and welfare projects undertaken by the Government agencies and in principle Stage-I approval orders may be issued subject to the following conditions.

- (iv) The fund from the User Agency towards NPV under this project shall be deposited by generating challan from the Ministry's online web portal UTR No and date should be furnished.

- (v) The Additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future shall by charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to the effect.
- (vi) The User Agency shall be responsible for any loss to Flora and Fauna in the surroundings and shall take all possible measures to conserve the same
- (vii) The forest land shall not be used for any other purpose other than that specified in the proposal.
