

Name of project proposal: **Proposal for diversion of 5.0112 ha of forest land for construction, Rehabilitation and upgrading to 2 lane with paved shoulders configuration of section from Rongli to Roleph (length of project Km 20 + 340 to 37 + 600) Section of NH-717 B in East Sikkim by NHIDCL.**


As per Stage-I (In-Principle) approval accorded by the Central Govt. vide letter No. SK/ROAD-38/2021/FC/257 dated 20.10.2021 under Section 2 of Forest (Conservation) Act, 1980, the cost of Compensatory Afforestation was charged as per pre-revised daily minimum wage rate vide Demand Note-I. Now, in compliance to revised minimum daily wage rates vide Notification No. 29/DL dated 14.09.2022 and recent guidelines issued by MoEF&CC for revision of rates of Net Present Value (NPV) vide No. 5-3/2011-FC(Vol-I), compensatory levies have been revised and the difference in cost is hereby charged as under:-
