- 2. The proposal is initiated by Mr. Laxman Kondu Chate for diversion of 0.0785 ha. Forest Land for laying of pipeline for agricultural irrigation. The total length of pipeline is 1970 Rmt. from which 1570 Rmt is passing through forest land.
- 3. The area belongs to Eco-value class-III and having density greater than 0.2.
- 4. The Deputy Conservator of Forests, Buldhana has certified that the forest land required is the barest minimum.
