The Government of India vide Ref (1) above has accorded in-principle (Stage-I) approval for diversion of 0.4858 ha of forest land in F.Sy No. 108A1* of Kodibag Village, Bada Hobli, Karwar Taluk, Uttar Kannada District for already established (prior to FCA) Fish Canning Factory and allied Fisheries Industries such as Ice Plants, Cold Storage, Quick Freezing Plant in favour of M/s Coronet Canning Company, Malpe, Udupi District under Section 2 of the Forest (Conservation) Act, 1980 subject

to certain conditions. Accordingly, the User Agency and field officers were directed by this office vide Ref (2) to submit the compliance to the conditions of Stage-I approval.

Accordingly, the User Agency vide Ref (3) has uploaded the condition wise. Compliance Report in respect of conditions stipulated in the 'in-principle' (Stage-I) approval on FC web portal. The same after verification has been received from the field officers vide Ref (4) & (5).
