Please refer to GoHP letter of even number dated 02.08.2017 on the above mentioned subject vide which "in-principle" approval of the Govt. of HP was given for diversion 0.6885 hectare of forest land for non-forestry purpose under Forest (Conservation) Act, 1980.

- 2. Now since amount of CA & NPV has been deposited by the user agency and after careful consideration of the proposal, the approval of the State Govt. is hereby conveyed for diversion of 0.6885 ha of forest land for the above mentioned project subject to the following conditions:-
  - 1. Legal status of the forest land will remain unchanged.
  - 2. Compensatory Afforestation is proposed to be raised in terms of number of plants, in DPF Bangoh. 230 plants shall be planted.
  - 3. Felling of 23 trees is involved over the forest land proposed for diversion.
  - 4. The forest land will not be used for any purpose other than mentioned in the proposal.
  - 5. No damage of any kind will be caused to the adjoining forest area and all the protection/preventive measures of stability of the area will be strictly adhered to.
  - 6. Muck/Debris generated during the construction, will be properly disposed, and not rolled down along hill slope.
  - 7. Demarcation of lease area to be done on the ground at project cost using four feet high rainforced cement concrete pillars with serial numbers, forward & back bearings and distance from pillar to pillar.
  - 8. The user agency will abide any condition that may be imposed by the State Forest Department in the interest of the protection and development of the forest area.
  - 9. It will be the responsibility of the user agency to obtain approval/clearance under all other relevant Acts/Rules/Court's Rulings/Instructions etc. as applicable to this proposal.

The Govt. may revoke/suspend the clearance if implementation of any of the above conditions is not satisfactory. The concerned DFO/CF & user agency will ensure fulfillment of these conditions.
