The Government of India vide Ref(1) dated 19.11.2020 has accorded 'in principle' (Stage-I) approval under Section(2) of Forest(Conservation) 1980 subject to certain conditions. Vide ref(5), the rates have been revised for the year 2023-24. Hence you are hereby informed pay the differential amount pertaining to raising of 10 times the number of trees to be felled in condition No.2.
