The Additional Principal Chief Conservator of Forests and Nodal Officer, Maharashtra State, Nagpur has submitted the proposal for diversion of 33.420 ha. Forest land under Forest (Conservation) Act, 1980 in favour of Executive Engineer, National Highway Authority of India, Nanded for for upgradation to two Lanes with paved shoulder to four lane configuration of Nanded-Kinwat-Mahur-Arni road section of National Highway 161 A in Nanded District of Maharashtra.

3. The proposal has been initiated by the Executive Engineer, National Highways Authority of India, Nanded for seeking approval under Forest (Conservation) Act, 1980 for Upgradation to Two Lanes with paved shoulder to Four Lane Configuration of Nanded-Kinwat-Mahur-Arni road section of National Highway 161A 0.00km at Bhoker and end at Arni Fata via Sarsam-Himayatnagar-Kinwat-Mahur of Nanded District in the State of Maharashtra. The existing road alignment passes through Forest area in a length of 147.650 Km in from chainage Km 51740 to Km 112780in the Districts of Nanded. Total non forest involved in the project is 327.049 ha. The project is approved vide Government of India, Ministry of Road Transport & Highways (Project Zone-6) letter No. NH-12014/172/2016-MAH(P-6), Dated 20/02/2017.

4. The Deputy Conservator of Forests, Nanded Forest Division, Nanded has certified that:-

- 4.1 no suitable alternate land is available and the forest land required is minimum.
- 4.2 the area belongs to Eco-value class-III having density less than 0.4 comes under Southern Tropical Dry Deciduous Forest.
- 4.3 there are 2115 trees of various species and trees is involved in implementation of the Project.
- 4.4 the area involved in the project does not form part of any existing National Park, Wildlife Sanctuary, Nature Reserve etc.
- 4.5 proposed project is not likely to affect any monumental site of cultural, historical, religious, archaeological or recreational importance.
- 4.6 there is no violation of Forest (Conservation) Act 1980.
- 4.7 The Eco Sensitive Zone of the Painagnga WLS has been notified by the MoEF & CC on 30/11/2016. In this regard the Additional Principal Chief of Forests & Field Director, Melghat Tiger Reserve vide his letter No.Desk-2/536, dt.31/8/2020 has offered his remarks that the proposed area for the project comprising 2.3 km passes from the non-forest area of the eco sensitive zone of the Painganga Wild Life Sanctuary. Having considered the remarks of the Additional Principal Chief of Forests & Field Director, Melghat Tiger Reserve the CWLW vide his letter dt.3/9/2020 has offered his comments that the proposal

should be kept before the Monitoring Committee under the Chairmanship of the Collector, Yavatmal for decision regarding mitigation measures.

- 4.8 the non-forest area covered under the project is not under the provision of Maharashtra Private Forest (Acquisition) Act 1975 by virtue of application of Section 35 of Indian Forest Act, 1927 and are not recognized as deemed reserved forest as well as not included in the area identified as "forest" as per dictionary meaning of forest as intimated to the expert committee appointed under interim judgment of the Hon'ble Supreme Court dated 12.12.1996.
- 4.9 and proposed Compensatory Afforestation over 67.00 ha. double degraded Reserve Forest land in Survey/Gut No.155,14,187,8,70,16,1 & Compartment No.408,388A,74A,191B, 256,57A,763 of Village Karla, Hunda G.P., Nichpur, Gogharwadi, Jaldhara, Mahadapur, Wagdari Dist. Nanded and it is contiguous, suitable for afforestation and management purpose and it is free from encroachment and an encumbrances.

5. The User Agency has submitted an undertaking that:-

- 5.1 agrees to defray the cost of compensatory afforestation.
- 5.2 agrees to defray the cost of Net Present Value of the forest land proposed under diversion.
- 5.3 the compliance under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 has been applied and is under process and shall be submitted before in-principle approval.
- 6. The Principal Chief Conservator of Forests (HoFF), Maharashtra State, Nagpur has recommended the proposal subject to the conditions, given in his specific recommendations, under Section-2 (ii) of the Forest (Conservation) Act, 1980. His specific recommendations are enclosed in the proposal.
- 7. In the circumstances explained in the aforesaid paragraphs and enclosures, the State Government recommends that the said forest land may be allowed to be diverted on the conditions proposed by the Principal Chief Conservator of Forests (HoFF), Maharashtra State, Nagpur with additional following condition:

'The Deputy Conservator of Forests, Nanded shall carry out site inspection in consultation with Principal Chief Conservator of Forests (Wildlife) and suggest mitigation measures for free movement of Wildlife. Mitigation measures approved by Principal Chief Conservator of Forests (Wildlife) will be binding on the User Agency.'

The matter may kindly be placed before the Government of India for its approval under Section-2 (ii) of the Forest (Conservation) Act, 1980, be obtained and communicated to this Government at earlier.
