Sub: Diversion of 21.404 ha (online 20,791 ha) Protected Forest land for construction of doubling of railway line of Ramna-Singrauli Section in Dhanbad Division in favour of Assistant Engineer (Construction) East Central Railway in Singrauli District of Madhya Pradesh.

Sir,

I am directed to invite a reference to APCCF (LM) & Nodal Officer, M.P. letter No. F-5/852/2018/10-11/518 dated 14/02/2019 on the above mentioned subject seeking prior approval of the Central Government under Section-2 of the Forest (Conservation) Act, 1980.

The Central Government vide letter (1) referred above had agreed In-principle for diversion of the above forest land for the purpose mentioned, subject to the fulfillment of all the conditions stipulated therein.

The State Government vide letter (2) referred above reported compliance on the fulfillment of the said conditions of the In-principle approval order.

Therefore, the undersigned is hereby directed to convey **formal approval** of the Central Government under Section-2 of the Forest (Conservation) Act, 1980 for diversion of 21.404 ha (online 20,791 ha) Protected Forest land for construction of doubling of railway line of Ramna-Singrauli Section in Dhanbad Division in favour of Assistant Engineer (Construction) East Central Railway in Singrauli District of Madhya Pradesh subject to the following terms and conditions:-

Specific Conditions:

1. Legal status of the forest land shall remain unchanged.
2. Forest land shall be handed over only after required non-forest land for the project is handed by the user agency.
3. **Compensatory afforestation :**
 - a) Compensatory Afforestation shall be taken up by the Forest Department over 50.00 ha de-graded forest land (Survey No. PF-102, Forest Range-Gorbi, Tehsil-Chitrangi, District-Singrauli). As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species shall be avoided.
 - b) Total No. of sapling to be planted shall be not less than 50,000 nos. (50.00 ha x 1,000) in CA land. The composition of saplings (number of species-wise) to be planted in the CA land shall be as per National Forest Policy and as per CA

scheme submitted vide APCCF(LM), Govt. of MP letter No. F-5/852/2018/10-11/1060 dated 11.04.2019 and record shall be kept.

- c) The standard size sapling (minimum height & minimum collar girth and maximum sturdiness quotient species wise) as approved by the State Govt. and as per specification in CA scheme submitted by APCCF(LM), Govt. of MP letter No. F-5/852/2018/10-11/1060 dated 11.04.2019 shall be planted in the selected CA land.
 - d) The height and collar girth (species wise) shall be measured & recorded at the time of plantation and in November of plantation year. Further, data of height, collar girth and survival percentage (species wise) twice a year (April & November month) shall be recorded & records shall be maintained.
 - e) All the live stumps and pollards having girth at ground level ≤ 90 cm and having coppicing properties present in this CA area shall be dressed from the ground level and girth-wise record shall be kept.
 - f) The CA plantation shall be taken place before end of 2022 monsoon.
4. User Agency shall restrict the felling of trees up to 290 to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
 5. The speed of the trains between Sun set and Sun rise while passing through the forest stretch shall not be more than 60 KMPH.
 6. The CWLW Govt. of Madhya Pradesh shall periodically monitor night speed limit and if desired may further reduce speed at night time and the recommendations of CWLW shall be binding on the User Agency.

General Conditions:

1. The User Agency shall provide suitable under pass/over pass for free movement of wildlife in and around the forest area in accordance to *Eco friendly measures to mitigate impacts of linear infrastructure on wildlife (2016)*.
2. The User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
3. The trees with bird nest, reptiles and habitat of wildlife was observed then such trees shall be treated with special care for relocation in the forest land by forest department at the cost of user agency.
4. The layout plan of the proposal shall not be changed without prior approval of Central Government.
5. No labour camp shall be established on the forest land.
6. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
7. The User Agency shall ensure that because of this project, no damage is caused to the Wildlife.
8. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
9. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
10. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
11. The State Government and user agency shall comply the provisions of the all Acts, Rules, Regulation, guidelines, NGR order & Hon'ble Court Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.

12. The forest land shall not be used for any purpose other than that specified in the project proposal.
13. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
14. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per MoEF&CC Guideline F.No. 11-42/2017-FC dt 29/01/2018 and Para 1.21 of FCA Handbook, 2019.
15. All the conditions stipulated in Stage-I/In-principle approval dated 18.10.2019 shall be strictly complied.
16. The user agency shall adhere to all rules, regulations, guidelines & acts enforced by State Govt. and Central Govt. for the proposal.
17. The six monthly Compliance Report for all the conditions stipulated in this Stage-II approval every year on 1st January and 1st July shall be uploaded on e.portal by the State Govt and submitted to this office also.
18. Any other condition that the Ministry of Environment, Forest and Climate Change may stipulate from time to time in the interest of conservation, protection and development of forest and wildlife.
19. In case of non-compliance of any of the above conditions, the concerned Divisional Forest officer shall report through the State Govt. to this office as per procedure laid down in the clause 1.9 of guidelines issued under Forest (Conservation) Act, 1980 on 25.10.1992.

This has been issued with the approval of the Competent Authority.
