Sub: Diversion of 15.811 ha of Forest land in favour of Western Coalfields Limited(WCL) for Transportation Network for Dinesh open cast Project in Tehsil Umred in Nagpur District in the State of Maharashtra- regarding.

The undersigned is directed to refer to State Government of Maharashtra's letter No. FLD-3421/CR-195/F-10 dated 23.03.2022 and APCCF & Nodal Officer (FCA), Maharashtra letter No. Desk-17/Nodal/Nagpur/I.D-12933/1298/2021-22 dated 20.10.2021 on the above subject seeking prior approval of the Central Government under Section-2 of the Forest (Conservation) Act, 1980 and APCCF & Nodal Officer (FCA), Maharashtra letter No. Desk-17/Nodal/Nagpur/ID-12933/181/2022-23 dated 24.04.2022 forwarding additional information as sought vide this office letter of even no. dated 18.04.2022 and to say that the said proposal has been examined in the Integrated Regional Office in light of the relevant provisions of the Forest (Conservation) Act, 1980 and Guidelines issued thereunder and approved by the Regional Empowered Committee constituted under Section-4 of the Forest (Conservation) Act, 1980.

After careful examination of the proposal of the State Government and on the basis of the approval of the proposal by the Regional Empowered Committee, the Central Government hereby accords '<u>in-principle</u>' approval under Section - 2 of the Forest (Conservation) Act, 1980 for diversion of 15.811 ha of Forest land in favour of Western Coalfields Limited(WCL) for Transportation Network for Dinesh open cast Project in Tehsil Umred in Nagpur District in the State of Maharashtra to the fulfilment of the following conditions:

i. Legal status of the forest land shall remain unchanged;

ii. Compensatory afforestation

a. Compensatory afforestation shall be taken up by the Forest Department over 35.797 ha degraded forest land in Survey No. 528, 530 at Village- Bhojapur, Taluka- Umred, Range- North Umred, Round- Kuhi, District- Nagpur (Area 9.997 ha.) and in Survey No. 21 at Village- Butibori, Taluka- Butibori, Range-Butibori, Round- Bhutibori East, District- Nagpur (Area 25.80 ha) at the cost of the User Agency. As far as possible, a mixture of local indigenous species along with 10% RET species of Nagpur District shall be planted and monoculture of any species may be avoided. Atleast two water bodies in each patch shall be

constructed in the form of tank/ stop dams etc if the same are not available in the area or in nearby vicinity;

iii. The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars on the CA land and fencing from boundary of forest land to protect narrow left over patch shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years. The fencing of the CA land to be started from the one side of compartment to avoid encroachment in future;

iv. NPV:

- a. The State Government shall charge the Net Present Value(NPV) for the 15.811 ha forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009 in this regard;
- b. Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect;
- v. User agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department;
- vi. All the funds received from the User Agency under the project shall be transferred/ deposited to CAMPA fund only through e-portal (https://parivesh.nic.in/);
- vii. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector;
- viii. To improve the Forest/ Tree cover and to reduce pollution in the State, as mandated in National Forest Policy, 1988 and Environmental (Protection) Act, 1986 respectively, the User Agency with involvement of Joint Forest Management Committees (JFMC's) and in consultation with local DCF shall raise at least 25,000 seedlings of forestry species along with bamboo, fruit bearing, medicinal, ornamental and indigenous/local for 10 years. At least 50% of seedlings shall be planted in the vicinity of project area and remaining 50% of seedlings shall be distributed among villagers as per choice of villagers. The concerned JFMC's shall maintain record of plantation/ seedling distribution to villagers;
 - ix. The User Agency in consultation with the State Forest Department shall carryout the at least two tier plantation in available space of RoW in both side of conveyor belt all through;
 - x. The User Agency in consultation with the State Forest Department shall carryout the avenue plantation in both side of railway loop;

- xi. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable;
- xii. The layout plan of the proposal shall not be changed without prior approval of Central Government;
- xiii. No labour camp shall be established on the forest land;
- xiv. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel;
- xv. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer;
- xvi. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work;
- xvii. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less;
- xviii. The Forest land shall not be used for any purpose other than that specified in the project proposal;
 - xix. The Forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India;
 - xx. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018;
 - xxi. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife;
- xxii. The compliance report shall be uploaded on e-portal (https://parivesh.nic.in/).

After receipt of a report on the compliance of conditions no iii, iv (a), v, vi, vii, and undertakings, duly authenticated by the competent authority in the State Government, in respect of all other conditions, from the State Government, formal approval will be considered in this regard under Section-2 of the Forest (Conservation) Act, 1980.

This issues with the approval of DDGF (C)/ Regional Officer (Central), Integrated Regional Office, MoEF & CC, Nagpur.
